

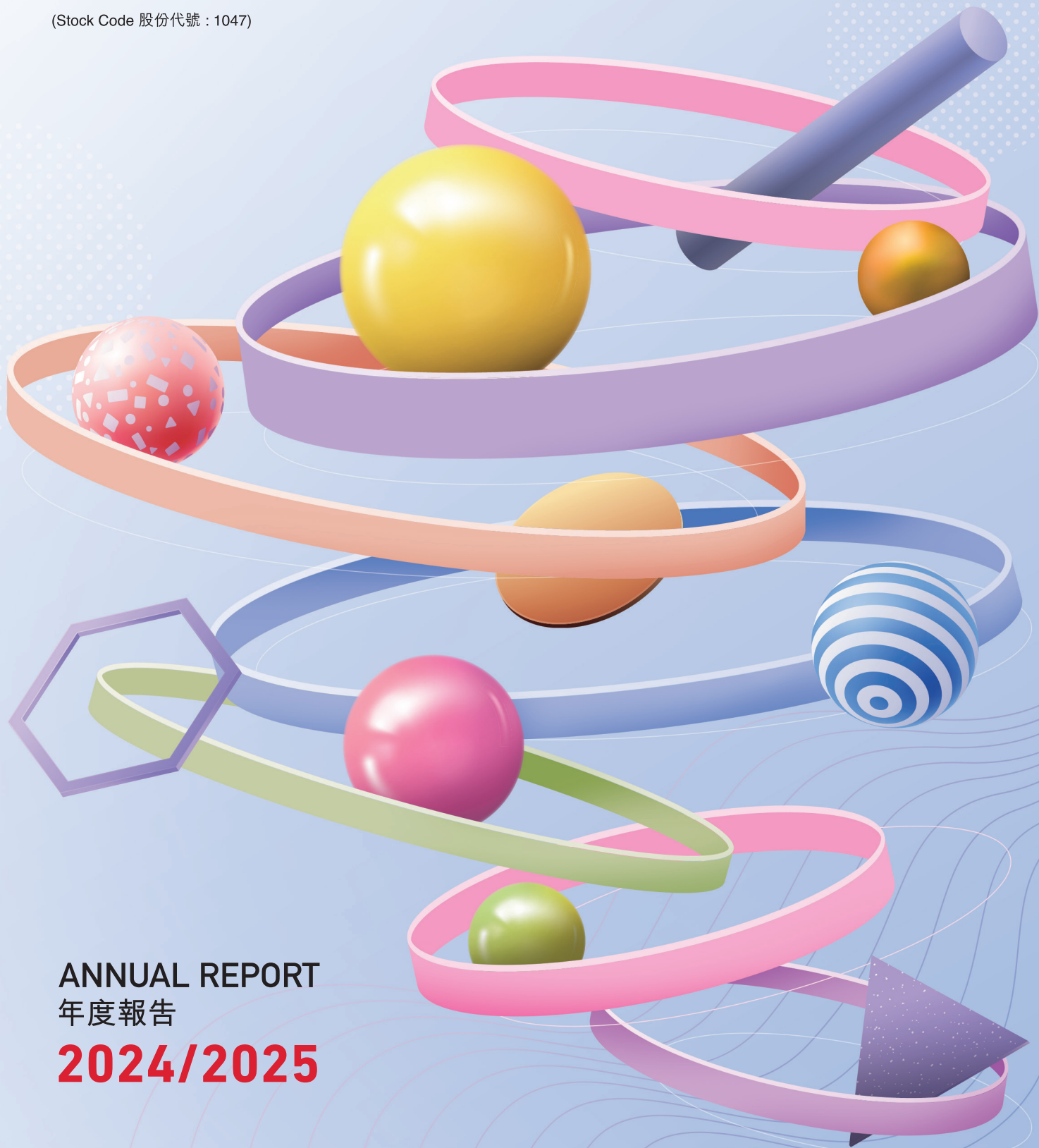

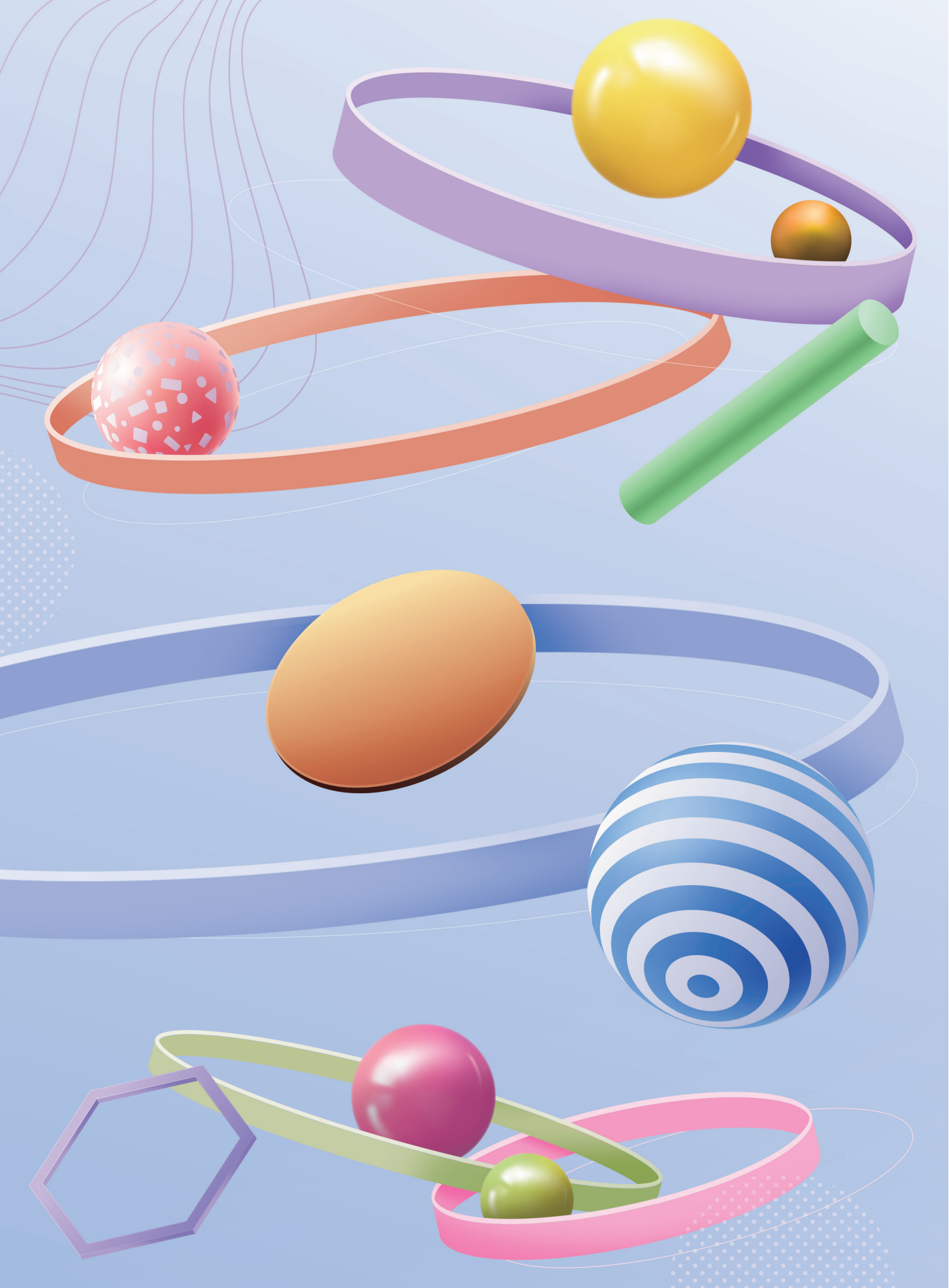

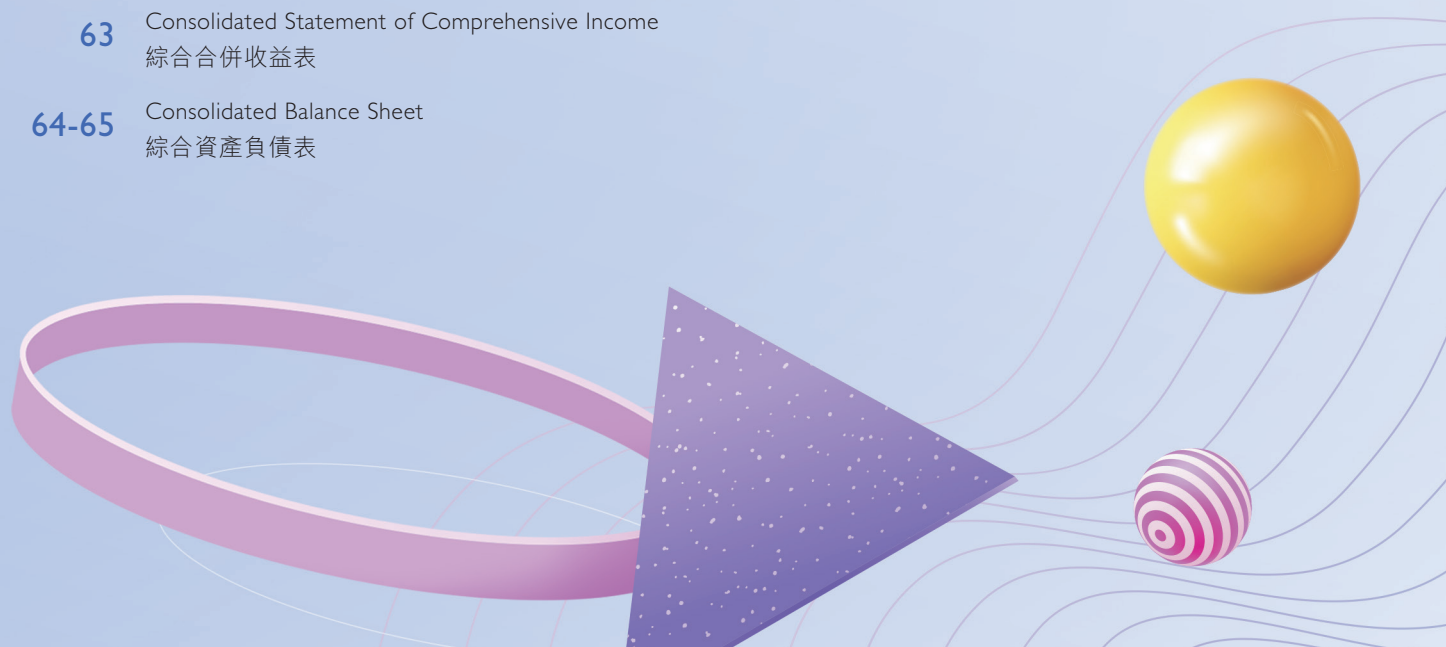

He has more than 55 years' experience in the plastics industry and he was awarded the Associateship (Plastic Industry) by The Professional Validation Council of Hong Kong Industries.

**Mr. NG Chi Ming**, aged 60, is the Technology Development Director of Greater China Department and Operations Director of Colorants Business of the Group. He is responsible for developing of plastics colouration, compounding technology and key accounts in the Greater China market. He holds a Higher Diploma in Textile Chemistry from the Hong Kong Polytechnic (The Hong Kong Polytechnic University's predecessor). He also holds a Master of Engineering Management degree from the University of Technology, Sydney. He joined the Group in 1988 and left in 1995. He re-joined the Group in early 1998 and has over 36 years' experience in plastic colouration and plastic injection moulding techniques.

**Mr. HUI Yan Kuen**, aged 48, is the General Manager of Ngai Hing Hong Plastic Materials (Hong Kong) Limited and is responsible for sales and marketing of plastic materials in the Group's trading business. ## RESULTS AND DIVIDEND

I hereby announce the audited results of Ngai Hing Hong Company Limited ("the Company") and its subsidiaries (collectively "the Group") for the year ended 30th June 2025. The Group recorded an audited consolidated turnover of HK\$1,348,511,000 (2024: HK\$1,276,350,000) and profit attributable to equity holders of the Company of HK\$339,000 (2024: loss attributable to equity holders of the Company of HK\$18,041,000). Earnings per share for the year were HK0.09 cent (2024: loss per share of HK4.89 cents). To retain sufficient capital for future business development, the Board of Directors (the "Board") does not recommend the payment of a final dividend.

## MANAGEMENT DISCUSSION AND ANALYSIS

### Business Review

In 2024/2025, the global political and economic environment remained complex and uncertain, with sluggish external end-market demand prevailing. U.S. tariff policy remained unclear, disrupting the global supply chain structure. This, plus the weak market consumption sentiment, made customers more cautious about placing orders, exerting sustained pressure on the overall operation of the industry. Facing market challenges and industry competition, the Group upheld its prudent business philosophy, continued to optimise its product portfolio, refine clientele structure, seized policy opportunities and advanced diversified layout to navigate the ebbs and flows of the fluctuating market. For the year ended 30th June 2025, the Group's total turnover reached HK\$1,348,511,000 (2024: HK\$1,276,350,000), a 5.7% increase against last year.

During the year under review, the Group's overall gross profit increased by 9.6% to HK\$218,491,000 (2024: HK\$199,263,000), with gross profit margin up slightly by approximately 0.6 percentage point year-on-year to 16.2%. Profit attributable to equity holders of the Company was HK\$339,000 (2024: loss attributable to equity holders of the Company of HK\$18,041,000). Basic earnings per share were HK0.09 cent (2024: basic loss per share of HK4.89 cents). In addition, leveraging its precise operational strategies, the Group recorded profit before income tax of HK\$9,470,000 (2024: loss before income tax of HK\$4,638,000) for the year, achieving a turnaround from loss to gain, with operating performance continuing to improve.

## 業績及股息

本人謹此報告毅興行有限公司(「本公司」)及其附屬公司(統稱「本集團」)截至二零二五年六月三十日止年度之經審核業績。本集團經審核之總營業額為1,348,511,000港元(二零二四年：1,276,350,000港元)，公司股東應佔盈利為339,000港元(二零二四年：公司股東應佔虧損18,041,000港元)，每股盈利為0.09港仙(二零二四年：每股虧損4.89港仙)。為保留充裕資金以發展業務，董事會建議不派發末期股息。

## 管理層討論及分析

### 業務回顧

二零二四／二五年度，全球政經環境依舊複雜不明，外圍終端需求疲弱勢態未改，美國關稅政策尚不明晰，影響全球供應鏈格局，加之市場消費氣氛不盡理想，客戶下單趨於審慎，令行業整體營運持續承壓。面對市場挑戰及行業競爭，本集團堅持穩健經營理念，持續優化產品組合，精耕客戶結構，緊抓政策機遇並推進多元化佈局，於市場波動中穩舵前行。截至二零二五年六月三十日止年度，本集團之總營業額達1,348,511,000港元(二零二四年：1,276,350,000港元)，較去年上升百分之五點七。

回顧年內，本集團整體毛利錄得百分之九點六的增長，達218,491,000港元(二零二四年：199,263,000港元)；毛利率按年微升約零點六個百分點至百分之十六點二。公司股東應佔溢利為339,000港元(二零二四年：公司股東應佔虧損18,041,000港元)。每股基本盈利為0.09港仙(二零二四年：每股基本虧損4.89港仙)。此外，憑藉精準的營運策略，本集團於年內錄得除稅前溢利9,470,000港元(二零二四年：除稅前虧損4,638,000港元)，實現轉虧為盈，經營勢頭持續向好。

### Business Review (Continued)

To reserve funds for business development, the Board of Directors does not recommend payment of a final dividend.

Regarding the plastic raw material trading business, the Group actively seized opportunities presented by favorable national policies, leveraging government subsidy programs for industries such as automobiles and home appliances to significantly improve the efficiency of domestic demand turnover, driving expansion in order volume. Despite the dual impacts of sluggish plastic material prices and tariff fluctuations, the Group's sales team was able to drive steady sales growth through strict cost control, cost reduction and efficiency improvement, as well as enhanced market penetration and active expansion of new customer sources, thus achieving a 11.1% year-on-year increase in turnover to HK\$857,240,000 (2024: HK\$771,942,000) for the business, with gross profit margin widening by a slight 1.1 percentage point. Benefiting from profit potential unleashed, loss before taxation narrowed by 56.3% to HK\$15,893,600 (2024: HK\$36,382,000).

During the year, despite the challenges from saturation of domestic production capacity and rising internal production costs, the colorants, pigments and compounded plastic resins business showed strong resilience. Government subsidy policy for the automotive industry also bolstered growth momentum of the business, and the Group capitalised on the policy tailwinds to deepen strategic synergy with customers in the automotive application industry. Traditional businesses, such as food packaging, remained stable and continued to provide solid support to the business. At the same time, by expanding domestic sales channels, the Group successfully maintained its overall production scale in Shanghai and Dongguan, effectively alleviating operating pressure from external market volatility. During the year, turnover of the colorants, pigments and compounded plastic resins business was HK\$358,179,000, decreased slightly by 2.5% as compared to that in the same period last year (2024: HK\$367,439,000), with gross profit margin also comparable to the same period last year. Profit before taxation was HK\$24,059,000 (2024: HK\$25,500,000).

### 業務回顧(續)

為保留充裕資金以發展業務，董事會建議不派發末期股息。

塑料原料貿易業務方面，本集團積極把握國家政策窗口機遇，依託汽車、家電等行業補貼政策，內需周轉效率顯著提升，訂單規模隨之擴張。縱受塑料價格低迷與關稅波動之雙重影響，本集團銷售團隊仍透過嚴控成本、降本增效，以及強化市場滲透，積極拓展新客源，成功推動銷量穩步增長，帶動該業務營業額同比上升百分之十一點一至857,240,000港元(二零二四年：771,942,000港元)，毛利率亦輕微改善一點一個百分點。得益於利潤空間的有效釋放，除稅前虧損收窄百分之五十六點三至15,893,600港元(二零二四年：36,382,000港元)。

年內，儘管面臨國內產能趨於飽和及內部生產成本上升的挑戰，着色劑、色粉及混料業務仍展現出較強韌性。汽車行業的國補政策亦為該業務注入增長動力，本集團乘政策東風，深化與汽車應用行業客戶的戰略協同；食物包裝等傳統業務亦持續穩健，為該業務提供堅實支持。同時，本集團亦透過拓展國內銷售渠道，成功維持於上海及東莞的整體生產規模，有效緩解外部環境波動帶來的經營壓力。年內，着色劑、色粉及混料業務的營業額與去年同期相比輕微下跌百分之二點五，錄得358,179,000港元(二零二四年：367,439,000港元)，毛利率亦與去年同期相若。除稅前溢利為24,059,000港元(二零二四年：25,500,000港元)。

### Business Review (Continued)

The engineering plastic products business is closely tied to the export market sentiment in Europe and the United States. Affected by tariff policy shocks, some customers tightened ordering strategies, creating periodic pressure on engineering plastic order volumes. In view of that, the Group adopted refined cost control and worked to stabilise its domestic customer base while expanding the overseas one. During the year, the business recorded turnover of HK\$133,092,000 (2024: HK\$136,969,000), with gross profit margin increasing by 2.8 percentage points, and profit before taxation up 1.8% year-on-year to HK\$11,064,000 (2024: HK\$10,868,000). The Group believes that once the tariff policy becomes stable, the business is expected to further improve operational efficiency by capitalising on its existing cost advantages and customer base.

### Prospects

In the second half of 2025, multiple challenges stemming from geopolitical and economic environment will persist. The Group will adhere to the strategic principle of “seeking progress while ensuring stability”, and implement its layout strategy of “balancing domestic and overseas operations with diversified synergy”. In addition to focusing on and seizing national policy trends to maintain its existing customer base and attract new customers, the Group will also target emerging overseas markets to develop a diversified customer portfolio to mitigate risks from policy fluctuations in any single market.

Currently, affected by geopolitics and market volatility, some customers slowed down their ordering pace. Though the short-term visibility is limited, customer orders have gradually stabilised when compared with the adjustment period in April this year. The Group will strive to steadily increase order volume, taking advantage of the domestic supportive policies. For export orders related to overseas end markets, the Group will actively capture growth opportunities by optimising production flexibility and customer base structure.

### 業務回顧(續)

工程塑料業務營運表現主要與歐美的出口市場氣氛密切相關。關稅政策衝擊下，部分客戶應勢收緊下單策略，令工程塑料訂單規模階段性承壓。有鑒於此，本集團採取精細化成本管控，內穩外拓客戶群，年內錄得營業額133,092,000港元(二零二四年：136,969,000港元)，毛利率提升二點八個百分點。除稅前溢利同比增加百分之一點八至11,064,000港元(二零二四年：10,868,000港元)。本集團相信，待關稅政策趨於穩定，該業務有望憑藉現有成本優勢及客戶基礎，進一步改善經營效益。

### 展望

二零二五年下半年，地緣政治及經濟環境帶來的多重挑戰仍存。本集團將持續秉持「穩中求進」的戰略方針，並實施「內外平衡、多元協同」的佈局策略。一方面聚焦並把握國家政策趨勢，維護基礎客戶群及拓展新客源；另一方面放眼海外新興市場，搭建多元化客戶體系，以分散單一市場政策波動風險。

當前，受地緣政治及市場波動影響，部分客戶下單節奏有所放緩，短期能見度有限，但較今年四月的調整期已逐步趨穩。本集團一方面將繼續依託國內相關扶持，力爭客戶訂單穩步增長；另一方面，針對海外市場終端出口相關訂單，將持續優化生產彈性與客戶群結構，積極捕捉增長契機。

### Prospects (Continued)

The Group's sales point in Vietnam, completed at the end of June 2024, has now achieved steady operation, which clearly confirms the strong potential of the Southeast Asian market. The Group plans to rationally allocate resources from its existing profitable business and identify regions with a stable investment environment and ample market potential to prepare for the establishment of overseas production bases.

Meanwhile, it will also strengthen development of end-customers in Southeast Asia and Europe to reduce the reliance on the US export chain end, as well as actively explore development opportunities in industries, such as automobiles and home appliances, that enjoy national support, deepening innovation in high-value-added application scenarios to groom new business growth drivers. Through the three-pronged approach of diversifying "origin of production, customer sources and business", the Group will enhance its risk resistance and improve its sustainable development capabilities.

In addition, as the fluctuations in customer orders also led to frequent adjustments to production schedules, the Group will continue to optimise cost management and production plans to enhance the flexibility of capacity allocation. It will also dynamically adjust inventory strategy to balance the cost advantages of bulk purchasing and the demand for stocking up for urgent orders. In the future, the Group will also continue to adopt its prudent financial management approach and optimise its financing structure to consolidate its capital strength to cope with numerous changes in the market.

Despite the complex and volatile macro environment fraught with challenges, under the leadership of a professional management team and the hard work and dedication of all employees, the Group remains confident in overcoming difficulties. The Group will adhere to its professional and prudent management strategy and pragmatic approach, continuously strengthening product innovation and cost control to steadily enhance core competitiveness. The Group will also be dedicated to promoting synergistic growth in business scale and profitability, striving for the best returns for all stakeholders.

### 展望(續)

本集團越南銷售據點於二零二四年六月末完成建設，現已實現穩定運營，充分印證東南亞市場的強大潛力，本集團進而計劃有序調配現有盈利業務資源，物色投資環境穩定、市場潛力充足之地區，以籌備海外生產基地建設。

與此同時，本集團亦將加強開拓東南亞及歐洲終端客戶，降低對美出口產業鏈終端之依賴，並積極探索汽車、家電等國家扶持產業之發展機遇，深化高附加值應用場景創新，培育業務新增長點。透過「產地、客源、業務」多元化三線並舉，本集團將強化抗風險能力，提升可持續發展實力。

此外，客戶訂單波動亦導致生產排期調整頻繁，本集團將繼續優化成本管理及生產計劃，提升產能調配靈活性；同時動態調整存貨策略，平衡批量採購成本優勢與急單備貨需求。未來，本集團亦將繼續採取審慎的理財方針，持續優化融資結構，鞏固資本實力以應市場萬變。

儘管宏觀環境複雜多變，挑戰叢生，依仗專業管理團隊的領導和全體員工的辛勞貢獻，本集團仍有信心迎難而上，恪守專業審慎的管理戰略和務實進取的經營態度，持續強化產品創新與成本管控，不斷提升核心競爭力。本集團亦將致力推動業務規模與盈利能力的協同增長，全力以赴為所有持份者爭取最佳回報。

## LIQUIDITY AND FINANCIAL RESOURCES

The Group generally finances its operations with internally generated cashflow and banking facilities provided by its principal bankers. As at 30th June 2025, the Group has available aggregate banking facilities of approximately HK\$662,792,000 of which approximately HK\$355,619,000 have been utilised and were secured by corporate guarantees issued by the Company and legal charges on certain property, plant and equipment, leasehold land and land use rights, investment properties and restricted bank deposits in Chinese Mainland and Hong Kong owned by the Group (see Notes 15, 16, 17, and 26 to the consolidated financial statements). The Group's cash and cash equivalents as at 30th June 2025 amounted to approximately HK\$193,161,000. The Group's gearing ratio as at 30th June 2025 was approximately 28.2%, which is calculated as net debt divided by total capital. Net debt is calculated as total borrowings less cash and cash equivalents. Total capital is calculated as equity plus net debt.

Details of the Group's capital commitments and the Company's contingent liabilities are disclosed in Notes 34 and 3.1(d) to the consolidated financial statements respectively.

## FOREIGN EXCHANGE RISK

The Group's borrowings and cash balances are primarily denominated in Hong Kong dollars, Renminbi and US dollars. The Group's purchases were principally denominated in US dollars. The Group closely monitors currency fluctuations and manages its exchange risk by entering into forward exchange contracts from time to time.

At 30th June 2025, the maximum notional amount for the outstanding settlement committed by the Group in respect of forward contracts in order to manage the Group's exposure in foreign currencies from its operations is as follows:

## 流動資金及財務資源

本集團一般以內部流動現金及主要銀行提供銀行貸款作為營運資金。於二零二五年六月三十日，本集團可動用銀行貸款額度約662,792,000港元，經已動用合共約355,619,000港元，該等貸款乃由本公司發出的擔保及本集團擁有之若干中國內地及香港物業、廠房及設備、租賃土地及土地使用權、投資物業及受限制的銀行存款之法定抵押作擔保（詳見綜合財務報表附註15、16、17及26）。本集團於二零二五年六月三十日之現金及現金等額約為193,161,000港元。本集團於二零二五年六月三十日之資產負債比率約為百分之二十八點二，此比率按照債務淨額除以總資本計算。債務淨額為總借貸減去現金及現金等額。總資本為權益加債務淨額。

有關本集團之資本承擔及本公司之或有負債已分別刊載於綜合財務報表附註34及3.1(d)。

## 外匯風險

本集團之借貸及銀行結存主要為港元、人民幣及美元。本集團的採購主要以美元計算。本集團不時密切監察匯率波動情況及透過對沖遠期外匯合約管理匯率波動風險。

為管理營運帶來之外匯風險，本集團訂立外匯遠期合約。於二零二五年六月三十日，本集團承擔之未交收最高設定本金額如下：

## Report of the Directors 董事會報告

The Directors submit their report together with the audited financial statements for the year ended 30th June 2025.

### PRINCIPAL ACTIVITIES AND GEOGRAPHICAL ANALYSIS OF OPERATIONS

The principal activity of the Company is investment holding. The principal activities of its principal subsidiaries are set out in Note 37 to the consolidated financial statements.

An analysis of the Group's performance for the year by segment is set out in Note 5 to the consolidated financial statements.

### BUSINESS REVIEW

A fair review of the Group's business and the analysis of the Group's performance for the year ended 30th June 2025 as well as prospects of the Group's business are provided in the "Chairman's Statement" on pages 8 to 14 of this Annual Report.

#### Principal Risks and Uncertainties

There are a number of factors affecting the results and business operations of the Group, some of which are inherent in the market and some are due to external environment. Major risks and uncertainties are summarised as follows:

- (i) Volatility of economic climate in Chinese Mainland and Hong Kong, which is closely related to consumption thereto.

In order to mitigate the impact of a weakening economy of Chinese Mainland, the Group is continuing to expand the overseas markets; and continues to take a cautious approach in steering the Group forward, and recognises the need to sustain sales momentum.

- (ii) Credit risk in the event of the counterparties' failure to perform their obligations.

The Group maintains a defined credit policy. An ageing analysis of trade debtors is prepared on a regular basis and is closely monitored to minimise any credit risk associated with receivables.

The Group's other financial risks and uncertainties are set out in Note 3 to the consolidated financial statements.

## DISTRIBUTABLE RESERVES

As at 30th June 2025, the reserves of the Company available for distribution, comprising the contributed surplus and retained earnings, amounted to approximately HK\$66,481,000 (2024: HK\$67,195,000).

Under The Companies Act 1981 of Bermuda (as amended), a company may not declare or pay a dividend, or make a distribution out of contributed surplus, if there are reasonable grounds for believing that (i) the company is, or would after the payment be, unable to pay its liabilities as they become due; or (ii) the realisable value of the company's assets would thereby be less than the aggregate of its liabilities and its issued share capital and share premium account.

## PRE-EMPTIVE RIGHTS

There is no provision for pre-emptive rights under the Company's Bye-laws and there was no restrictions against such rights under the laws of Bermuda, which would oblige the Company to offer new shares on a pro-rata basis to existing shareholders.

On 17th November 2022, the Company has adopted a share option scheme (the "Scheme") and terminated the share option scheme adopted by the Company on 22nd November 2012. Under the terms of the Scheme, the Directors may, at their discretion, invite eligible participants to take up Share Options to subscribe for the shares of the Company subject to the terms and conditions stipulated therein.

Details of the Scheme are as follows:

(i) *Purpose*

The purpose of the Scheme is to enable the Group to grant Share Options to eligible participants as incentives or rewards for their contribution to the Group.

(ii) *Eligible participants*

Any employee (whether full time or part time, including any executive director but excluding any non-executive director) of the Company or any of its subsidiaries; and the persons to whom the Directors may extend an offer to take up Share Options as referred to in paragraph (2) of Appendix II of the circular issued by the Company on 18th October 2022.

(iii) *Maximum number of shares*

The maximum number of shares, which may be issued upon exercise of all outstanding Share Options granted and yet to be exercised under the Scheme and any other share option schemes of the Company shall not exceed 30% of the total number of shares in issue from time to time. No Share Option may be granted under the Scheme if such limit is exceeded. The total number of shares available for issue under the Scheme as at the date of the annual report is 36,920,000, which is 10% of the issued share capital of the Company as of that date.

The maximum entitlement for any one qualifying participant is that the total number of shares issued and to be issued upon exercise of the Share Options granted to each qualifying participant under the Scheme and any other option schemes (including exercised and outstanding Share Options) in any 12-month period shall not exceed 1% of the total number of shares in issue.

The exercise price in respect of any particular option shall be (i) the closing price of the shares of the Company as stated in the Stock Exchange daily quotations sheet on the date of offer for the grant of a Share Option, (ii) the average price of the shares for the five business days immediately preceding the date of offer for the grant of a Share Option or (iii) the nominal value of the share (whichever is the greater).

(vii) *The remaining life of the Scheme*

The Board of Directors shall be entitled at any time within 10 years between 17th November 2022 and 16th November 2032 to offer the grant of an option to any qualifying participants.

(viii) *Total number of shares*

The total number of shares which may be allotted and issued upon exercise of all Share Options (excluding, for this purpose, Share Options which have lapsed in accordance with the terms of the Scheme and any other share option scheme of the Group) to be granted under the Scheme and any other share option scheme of the Group must not in aggregate exceed 10% of the Shares in issue as at 17th December 2022 (the "General Mandate Limit"). The maximum number of Shares may be issued upon exercise of the Options granted under the General Mandate Limit is 36,920,000 shares. No Share Options have been granted since the adoption of the Scheme. There is no change in the number of Share Options available for grant under the Scheme mandate at the beginning and the end of the financial year.

## CORPORATE GOVERNANCE PRACTICE

The Company is committed to the establishment of good corporate governance practices and procedures which serve as an important element of risk management throughout the growth and expansion of the Company. The Company emphasises on maintaining and carrying out sound, solid and effective corporate governance principles and structures.

The Company has complied with all the applicable code provisions as set out in Corporate Governance Code and Corporate Governance Report to the Appendix C1 of the Listing Rules (the “CG Code”) throughout the year ended 30th June 2025, except for the deviation as mentioned below.

According to the code provision C.2.1 of the CG Code, the roles of chairman and chief executive officer (chief executive for CG Code) should be separate and should not be performed by the same individual. Up to the date of this Annual Report, the board (the “Board”) of directors (the “Directors”) of the Company has not appointed any individual to be the chief executive. The roles of the chief executive have been performed collectively by all the executive Directors, including the chairman, of the Company. The Board considers that this arrangement allows contributions from all executive Directors with different expertise and is beneficial to the continuity of the Company's policies and strategies. Going forward, the Board will periodically review the effectiveness of this arrangement and considers appointing an individual as chief executive when it thinks appropriate.

## DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code as set out in Appendix C3 of the Listing Rules as its own code of conduct regarding directors' securities transaction. The Company has made specific enquiries to all Directors and all Directors confirmed they have complied with the required standard of dealings set out therein during the year.

### Composition of the Board, number of Board meetings and Directors' attendance (Continued)

The balanced board composition ensured strong independence exists across the Board and has met Rule 3.10A of the Listing Rules to have at least one-third of its members comprising independent non-executive Directors. At least one of the independent non-executive Directors has appropriate professional qualifications, accounting or financial management expertise. The biographies of the Directors are set out on pages 4 to 7 to the Annual Report, which demonstrates a diversity of skills, expertise, experience and qualifications.

The Independent Non-executive Directors have been appointed for a term subject to retirement by rotation in accordance with the Company's Bye-laws.

The Company has received annual confirmation of independence from the three Independent Non-executive Directors in according with Rule 3.13 of the Listing Rules. The Board has assessed their independence and concluded that all the Independent Non-executive Directors are independent within the definition of the Listing Rules.

### Role and Function

The Board delegates day-to-day operations of the Group to the executive Directors and senior management, while reserve certain key matters for its approval. The principal functions of the Board are:

- to establish the strategic direction for the development of the Company and set the objectives of the management;
- to approve annual budgets, major funding proposal and investment proposals;
- to decide on matters such as annual and interim results, major transactions, directors appointment, and dividend and accounting policies; and
- to oversee the processes for evaluating the adequacy of internal controls, risk management, financial reporting and compliance.

### 董事會組成、董事會會議及董事出席次數(續)

董事會以均衡之架構組成，目的在確保整個董事會擁有穩固之獨立性，其組成情況符合上市規則第3.10A條董事會成員最少須有三分之一為獨立非執行董事之規定。最少有一位獨立非執行董事擁有相關的會計或財務管理之專業資格。各董事履歷載於年報第4至7頁，當中載列各董事之多樣化技能、專業知識、經驗及資格。

獨立非執行董事乃根據本公司之公司細則獲委任，惟彼等須輪值告退。

本公司已接獲全數三名獨立非執行董事根據上市規則第3.13條發出之年度獨立性確認書。董事會已評估彼等之獨立性，並確定全體獨立非執行董事均屬上市規則所界定之獨立人士。

### 角色及職責

董事會將本集團日常運作委派予執行董事及高層管理人員，但保留部分重要事項之審批權力。董事會的主要職責包括：

- 設立本公司的策略性發展方向及制定管理目標；
- 批准年度預算、主要籌資提案及投資提案；
- 決定如年度及中期業績、重大交易、董事之委任、及股息和會計政策等事宜；及
- 檢查用於評估內部監控、風險管理、財務報告及遵守情況充分性的程序。

### **Directors' Responsibilities for the Financial Statements**

The members of the Board are responsible for preparing the financial statements of the Company and of the Group. The financial statements are prepared on a going concern basis and give a true and fair view of the state of affairs of the Company and of the Group as at 30th June 2025, and of the Group's profit and cash flows for the year then ended. In preparing the financial statements for the year ended 30th June 2025, the members of the Board have selected appropriate accounting policies and, apart from those new and amended accounting policies as disclosed in the notes to the consolidated financial statements for the year ended 30th June 2025, have applied them consistently with previous financial periods. Judgments and estimates that have been made are prudent and reasonable.

During the year ended 30th June 2025, the management provided all members of the Board with monthly updates in accordance with the code provision D.1.2 of the CG Code.

The reporting responsibilities of the external auditor are set out on pages 59 to 61.

### **Continuing Professional Development**

All Directors, namely, Mr. HUI Sai Chung, Mr. HUI Kwok Kwong, Mr. NG Chi Ming, Mr. HUI Yan Kuen, Mr. HUI Man Wai, Mr. HUI Yan Lung, Geoffrey, Mr. HO Wai Chi, Paul (Resigned on 20th December 2024), Mr. CHING Yu Lung, Mr. YU Chi Kwong and Ms. LIU Sau Lai (Appointed on 20th December 2024) have participated in continuous professional development by engaging in business activities beneficial to the Company in their respective fields, including attending seminar, workshops, conference and courses offered by professional bodies and self-studying, to develop and refresh their knowledge and skills so as to ensure that their contribution to the Board remains informed and relevant.

The Company is committed to arranging and funding suitable training to all Directors for their continuous professional development. During the year ended 30th June 2025 and up to the date of this annual report, the Company has arranged to provide the Directors with briefing on the amendments to the Listing Rules and self-studying materials.

### **持續專業發展**

全體董事(許世聰先生、許國光先生、吳志明先生、許人權先生、許文偉先生、許人龍先生、何偉志先生(於二零二四年十二月二十日辭任)、程如龍先生、余志光先生及廖秀麗女士(於二零二四年十二月二十日獲委任)已分別於他們的範疇參與對本公司有益的業務活動，以達致持續專業發展之目的，當中包括出席由專業團體舉辦的座談會、工作坊、會議及課程；與及個人進修，以發展及更新他們的知識及技術並確保他們對董事會作出資訊性及相關的貢獻。

本公司亦承擔替全體董事安排及資助適合他們的持續專業發展之培訓。於截至二零二五年六月三十日止年度內及直至本年度報告日止，本公司已安排向董事提供上市規則的修訂之簡報，與及相關的個人進修材料。

### Directors' and Officers' Liabilities

The Company has arranged for appropriate insurance covering the liabilities of the Directors that may arise out of the corporate activities, which has been complied with the CG Code. The insurance coverage is reviewed on an annual basis.

### Director's Nomination Policy

The Director's nomination policy of the Company was adopted by the Board and became effective on 1st January 2019 and the nomination committee of the Company (the "Nomination Committee") is responsible for execution.

### Director Nomination Process

The Nomination Committee utilises various methods for identifying director candidates, including recommendations from Board members, management, and headhunters. The Nomination Committee may also put forward director candidates who are not nominated by Board members. In addition, the Nomination Committee will consider director candidates properly submitted by shareholders of the Company through formal procedures set out in the Company's Procedures for Shareholders to Propose a Person for Election as a Director.

For filling a casual vacancy, the Nomination Committee shall make recommendations for the Board's consideration and approval. For proposing director candidates to stand for election at a general meeting, the Nomination Committee shall make nominations to the Board for its consideration and recommendation.

All director candidates, including incumbents and candidates nominated by shareholders of the Company are evaluated by the Nomination Committee based upon the Director's qualifications. While director candidates will be evaluated on the same criteria, the Nomination Committee retains the discretion to establish the relative weighting of such criteria, which may vary based on the composition, skill sets, and experiences of the collective Board rather than on the individual candidate.

The Board shall have the final decision on all matters relating to the recommendation of director candidates by the Nomination Committee to stand for election at any general meeting. The Board will take such recommendations under advisement and is responsible for designating the director candidates to be elected at the annual general meeting of the Company and electing Directors to fill Board vacancies.

### 董事及重要職員責任

本公司已附合守則規定，就董事因企業行為所產生之責任安排適當的保險，並會每年就投保額作出檢討。

### 提名董事的政策

提名董事的政策經董事會採納並於二零一九年一月一日起生效，由本公司的提名委員會(「提名委員會」)負責執行。

### 董事提名程序

提名委員會運用各種方法物色董事人選，當中包括董事會成員、管理層及專業獵頭公司之推薦建議，提名委員會亦可提名未獲董事會成員提名的董事候選人。此外，提名委員會將會考慮由本公司股東經載於本公司股東提名候選董事的程序的正式程序妥善提交之董事人選。

如要填補臨時空缺，提名委員會須推薦人選供董事會考慮及批准。如要推薦董事候選人在股東大會上參選，提名委員會須向董事會提名供其考慮及推薦參選。

所有董事候選人(包括現任董事及本公司股東提名之候選人)均由提名委員會基於董事資格進行評估。儘管董事候選人將按相同準則進行評估，但提名委員會保留為該等準則制定相對比重之酌情權，而該比重或會根據董事會整體之組成、技能及經驗而有所變更，而非按個別候選人釐定。

董事會對於其推薦候選人在股東大會上參選的所有事宜有最後決定權。董事會將詳細考慮有關推薦建議，並負責指定將於本公司股東週年大會上獲選舉之董事候選人及挑選董事以填補董事會之空缺。

### **Procedure for Appointment of New Director**

Director candidates will be asked to submit the necessary personal information in a prescribed form, together with their written consent to be appointed as a Director and to the public disclosure of their personal data on any documents or the relevant websites for the purpose of or in relation to their standing for election as a Director.

The Nomination Committee shall, upon receipt of the proposal on appointment of new Director and the biographical information (or relevant details) of the director candidate, evaluate such director candidate based on the criteria as set out below to determine whether such director candidate is qualified for directorship.

If the process yields one or more desirable director candidates, the Nomination Committee shall rank them by order of preference based on the needs of the Company and reference check of each director candidate (where applicable).

For any person that is nominated by a shareholder of the Company for election as a Director at the general meeting of the Company, the Nomination Committee shall evaluate such director candidate based on the criteria as set out below to determine whether such director candidate is qualified for directorship and where appropriate, the Nomination Committee and/or the Board shall make recommendation to shareholders of the Company in respect of the proposed election of Director at the general meeting (where applicable).

A director candidate is allowed to withdraw his/her candidature at any time before the general meeting by serving a notice in writing to the company secretary of the Company.

Until the issue of the shareholder circular, the nominated persons shall not assume that they have been proposed by the Board to stand for election at the general meeting.

### **Procedure for Re-appointment of Director at General Meeting**

The Nomination Committee shall review the overall contribution and service to the Company of the retiring Directors including their attendance of Board meetings and, where applicable, general meetings, and the level of participation and performance on the Board.

### **委任新董事的程序**

董事候選人將會被要求按既定格式提交所需的個人資料，以及提交同意書，同意被任為董事，並同意就其參選董事或與此有關的事情在任何文件或相關網站公開披露其個人資料。

提名委員會應在收到委任新董事的建議及董事候選人的個人資料(或相關詳情)後，依據以下列明的準則評估該董事候選人，以決定該董事候選人是否合資格擔任董事。

如過程涉及一個或多個合意的董事候選人，提名委員會應根據本公司的需要及每位董事候選人的證明審查(如適用)排列他們的優先次序。

任何經由本公司股東提名就於本公司股東大會上選舉為董事的人士，提名委員會應依據以下列明的準則評估該董事候選人，以決定該董事候選人是否合資格擔任董事，並且，提名委員會及／或董事會應就於股東大會上委任董事向本公司股東提出建議(如適用)。

董事候選人可於股東大會舉行前任何時候向公司秘書發出書面通知退選。

在直至發出股東通函前，被提名人士不可假設其已獲董事會推薦在股東大會上參選。

### **於股東大會上重選董事的程序**

提名委員會應檢討退任董事對本公司的整體貢獻及服務，包括其出席董事會會議及股東大會(如適用)的出席率，以及在董事會的參與程度及表現。

### Procedure for Re-appointment of Director at General Meeting (Continued)

The Nomination Committee shall also review and determine whether the retiring Directors continue to meet the criteria as set out below.

The Nomination Committee and/or the Board shall then make recommendation to the shareholders of the Company in respect of the proposed re-election of Directors at the general meeting.

### Director Selection Criteria

The Nomination Committee considers the following qualifications are at a minimum to be required of a director candidate in recommending to the Board potential new Director, or the continued service of existing Director:

- (a) the highest personal and professional ethics and integrity;
- (b) proven achievement and competence in the nominee's field and the ability to exercise sound business judgment;
- (c) qualifications including professional qualifications, skills, knowledge and experience that are complementary to those of the existing Board;
- (d) the ability to assist and support management and make significant contributions to the Company's success;
- (e) the contribution on diversity of the Board and any measurable objectives adopted by the Nomination Committee for achieving diversity on the Board;
- (f) an understanding of the fiduciary responsibilities that is required of a member of the Board and the commitment of time and energy necessary to diligently carry out those responsibilities; and
- (g) meet the "independence" criteria as required under the Listing Rules and the composition of the Board is in conformity with the provisions of the Listing Rules from time to time (where applicable).

Other than the foregoing, there are no stated minimum criteria for director candidate, although the Nomination Committee may also consider such other factors as it may deem to be in the best interests of the Company and the shareholders of the Company.

提名委員會及／或董事會應就於股東大會上重選董事向股東提出建議。

### 董事甄選準則

提名委員會認為以下為向董事會推薦董事候選人作為潛在新董事或現有董事持續就任所需之最低資格：

- (a) 最高水平之個人及專業操守和誠信；
- (b) 於獲提名人之範疇內具備過往實績及能力，並有能力行使良好之商業判斷；
- (c) 補足現有董事會之資格，包括專業資格、知識、技能及經驗；
- (d) 有能力協助及支援管理層，並為本公司達致成功作出重大貢獻；
- (e) 促進董事會成員多元化及任何由提名委員會所採納以達致董事會成員多元化的可計量目標；
- (f) 明白董事會成員所需承擔之受信責任，以及妥善履行該等責任所需投入之時間及精力；及
- (g) 須達到聯交所不時更新的上市所規定之「獨立性」準則，且董事會組成須遵守上市規則之條文(如適用)。

- In assessing the suitability of Director candidates, the Nomination Committee will review their profiles, including their qualification and time commitment, having regard to the Board's composition, the Directors' skill matrix, the list of selection criteria approved by the Board, the director nomination policy and the board diversity policy.
- Independent non-executive Directors receive fixed fee(s) for their roles as members of the Board and Board Committee(s) as appropriate.
- The Nomination Committee reviews annually each Director's time commitment to the Company's business. Directors' attendance records in the year are disclosed in the Corporate Governance Report contained in this Annual Report.
- Independent non-executive Directors' independence is assessed upon appointment, annually, and at any other time where the circumstances warrant reconsideration.
- The Company provides guidance to Directors on avoiding conflicts of interest and on the circumstances under which appropriate action(s) shall be taken by a Director in conflict.
- To facilitate proper discharge of their duties, all Directors are entitled to seek advice from the Group's company secretary or the in-house legal team as well as from independent professional advisers at the Company's expense.

### **Board Diversity Policy**

The Board has updated a board diversity policy (the “Board Diversity Policy”) in July 2022 which sets out the approach to achieve diversity on the Board.

With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service.

The Board has reviewed the current composition and is committed to achieve gender diversity on the Board by maintaining an appropriate level of female members on the Board and to provide the Company with a good balance and diversity of skills and experience appropriate to the requirements of its business. The Board has appointed a female Director on 20th December 2024. The Board will continue to review its composition from time to time taking into consideration specific needs for the Group's business.

### **Independence**

The Board includes a balanced composition of executive, non-executive and independent non-executive Directors so that there is a strong element of independence in the Board. The independent non-executive Directors shall be of sufficient caliber and stature for their views to carry weight.

The same principle is applied to the selection of potential candidates for appointment to the Board.

### Skills and experience

The Board members should possess a balance of skills appropriate for the requirements of the business of the Group, including the independent non-executive Directors possessing professional accounting and other qualifications. The Directors have a mix of finance, academic and management backgrounds that taken together provide the Group with considerable experience in a range of activities including varied industries, education, government, investment and the professions.

### Measurable Objectives

1. The Company should comply with the requirements on board composition under the Listing Rules from time to time.
2. The number of independent non-executive Directors should be not less than three and one-third of the Board.
3. At least one of the independent non-executive Directors must have appropriate professional qualifications or accounting or related financial management expertise.
4. At least one Director should be the professional or have intensive experience of the industry on which the business of the Group is.

Having reviewed the Board Diversity Policy and the Board's composition, the Nomination Committee considered that the requirements of the Board Diversity Policy had been met.

### Role and Function

The Corporate Governance Committee held three meetings during the year ended 30th June 2025 to review the corporate governance policy in the Group and recommend the training arrangement on corporate governance to the employees of the Group.

## INTERNAL CONTROL AND RISK MANAGEMENT

The Board is responsible for overseeing the risk management and internal control systems of the Group and reviewing their effectiveness. The Group has formulated and adopted a risk management process which includes risk identification, risk evaluation, risk mitigation, risk monitoring and reporting. At least on an annual basis, the management of the Company identifies risks that would adversely affect the achievement of the Group's objectives, and assesses and prioritises the identified risks according to a set of standard criteria. Risk mitigation plans are then established for those risks considered to be significant, which include regular reporting to the Audit Committee and the Board.

The management of the Company has established a set of comprehensive policies, standards and procedures in areas of operational, financial and risk controls for safeguarding assets against unauthorised use or disposition; for maintaining proper accounting records; and for ensuring the reliability of financial information to achieve a satisfactory level of assurance against the likelihood of the occurrence of fraud and errors. In addition, the Group has established internal control protocols and control self-assessment process on major operations. Assessment results are submitted to the Board for ongoing monitoring purpose.

### *Risk Management System*

The Group adopts a risk management system which manages the risk associated with its businesses and operations. The system comprises the following phases:

- Identification: identify ownership of risks, business objectives and risks that could affect the achievement of objectives;
- Analysis and Assessment: analyse the likelihood and impact of risks and evaluate the risk portfolio accordingly; and
- Risk Response and Monitoring: consider the risk exposures, ensure effective communication to the Board and monitor the residual risks on an ongoing basis.

## 內部監控及風險管理

董事會需負責監察本集團的風險管理及內部監控系統及檢討其效能。本集團已制定及採納風險管理程序，包括風險識別、風險評估、風險轉移、風險監控及匯報。本公司管理層每年最少進行一次識別對達致本集團目標有不良影響之風險，並根據一系列標準規範評估已發現風險及排列優先次序，然後就視作重大的風險建立風險轉移計劃，當中包括向審核委員會及董事會匯報。

本公司的管理層已制定一套完善的政策、標準及程序，範圍包括運作監控、財務監控及風險監控，以保證資產得到保護並免受未經授權的使用或處置；保持適當的會計紀錄；及確保財務資料的可靠性，以達致滿意程度的保證，防止欺詐或錯誤的情況出現。此外，本集團已就主要經營建立內部監控協定及監控自我評估程序，評估結果提交予董事會以作持續監控。

### *風險管理系統*

本集團已採納一套風險管理系統以管理有關其業務及營運的風險。該系統包括以下層面：

- 識別：識別風險所有權、業務目標及可能影響目標達成的風險；
- 分析及評估：分析風險的可能性及影響並對風險組合作出相應評估；及

- Control environment: a set of standards, processes and structures that provide the basis for carrying out internal control across the Group;
- Risk assessment: a dynamic and iterative process for identifying and analysing risks to achieve the Group's objectives, forming a basis for determining how risks should be managed;
- Control activities: actions established by policies and procedures to ensure that management's directives to mitigate risks for the achievement of objectives are carried out;
- Information and communication: internal and external communications to provide the Group with the information needed to carry out the daily controls; and
- Monitoring: ongoing and separate evaluations to ascertain whether each component of the internal control system is present and functioning.

For the purpose of enhancing the risk management and internal control systems, the Company has engaged an external consultant to assist the Board and the Audit Committee in ongoing monitoring and in performing the internal audit functions for the Group. Deficiencies in the design and implementation of internal controls are identified and recommendations are proposed for improvement. Significant internal control deficiencies are reported to the Audit Committee and the Board on a timely basis to ensure prompt remediation actions are taken.

The Board has reviewed and considered the Group's risk management and internal control systems were effective and adequate during the year. The risk management and internal control systems of the Group are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

If a Shareholder wishes to propose a person (the "Candidate") for election as a Director at a general meeting, he/she shall deposit a written notice (the "Notice") at the Company's head office in Hong Kong at Unit 3, 6th Floor, Hopeful Factory Centre, 10 Wo Shing Street, Fo Tan, Shatin, New Territories, Hong Kong. The Notice (i) must include the personal information of the Candidate as required by Rule 13.51(2) of the Listing Rules and his/her contact details; and (ii) must be signed by the Shareholder concerned including the information/documents to verify the identity of the Shareholder and signed by the Candidate indicating his/her willingness to be elected and consent of publication of his/her personal data. The period for lodgement of the Notice shall commence on the day after the dispatch of the notice of general meeting and end no later than seven days prior to the date of such general meeting. In order to ensure the Shareholders have sufficient time to receive and consider the proposal of election of the Candidate as a Director without adjourning the general meeting, Shareholders are urged to submit and lodge the Notice as soon as practicable, say at least fifteen business days prior to the date of the general meeting appointed for such election.

The Board has established a shareholders communication policy on 26th March 2012 and will review it on a regular basis to ensure its effectiveness to comply with the code provision F.1 of the CG Code.

- the retained earnings and distributable reserves of the Group;

- the shareholders' and the investors' expectation and industry's norm;
- any restrictions on payment of dividends that may be imposed by the Group's lenders;
- statutory and regulatory restrictions;
- past dividend records; and
- any other factors the Board may deem relevant.

The Company shall review and reassess the Dividend Policy and its effectiveness from time to time. Any revisions to the Dividend Policy shall be considered and approved by the Board.

## Notes to the Consolidated Financial Statements 綜合財務報表附註

### I GENERAL INFORMATION

Ngai Hing Hong Company Limited (the “Company”) and its subsidiaries (together the “Group”) are principally engaged in the manufacturing and trading of plastic materials, pigments, colorants, compounded plastic resins and engineering plastic products.

The Company is a limited liability company incorporated in Bermuda. The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM11, Bermuda.

The Company’s shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited.

These consolidated financial statements are presented in Hong Kong dollars (“HK\$”), unless otherwise stated. These consolidated financial statements have been approved for issue by the Board of Directors on 29th September 2025.

### 2 BASIS OF PREPARATION

(i) *Compliance with HKFRS Accounting Standards and the disclosure requirements of Hong Kong Companies Ordinance*

The consolidated financial statements of the Group have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRS”) Accounting Standards as issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the disclosure requirements of the Hong Kong Companies Ordinance Cap. 622.

(ii) *Historical cost convention*

The consolidated financial statements have been prepared under the historical cost convention, except for certain financial assets and liabilities (including financial asset at fair value through other comprehensive income (“FVOCI”), financial assets at fair value through profit or loss (“FVPL”) and derivative financial instruments) and investment property which are measured at fair value.

### 3.1 *Financial risk factors*

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, cash flow and fair value interest rate risk and price risk), credit risk and liquidity risk. The Group's overall risk management policy focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Management regularly monitors the financial risks of the Group. The use of financial derivatives to hedge certain risk exposures is governed by the Group's policies approved by the Board of Directors of the Company in order to manage those risks. The Group does not use derivative financial instruments for speculative purposes.

本集團經營活動面對各種財務風險：市場風險(包括外匯風險、現金流量及公允價值利率風險及價格風險)、信貸風險及流動資金風險。本集團整體風險管理計劃針對難以預測的金融市場，以將對本集團財務表現的潛在不利影響降至最低。

管理層定期管理本集團之財務風險。用作對沖若干風險的衍生金融工具由本公司董事局批准的政策所規管。本集團一般會透過簽訂遠期外匯合約以管理其外匯風險。本集團並無運用衍生金融工具作投機活動。

#### 3.1 Financial risk factors (Continued)

##### (a) Foreign exchange risk

The Group mainly operates in Hong Kong and Chinese Mainland with transactions mainly settled in Hong Kong dollar ("HK\$"), Renminbi ("RMB") and US dollar ("USD"). Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency. The Group is exposed to foreign exchange risk from various currency exposures, primarily with respect to USD and RMB.

Management has a policy to require group companies to manage their foreign exchange risk against functional currency. It mainly includes managing the exposures arise from sales and purchases made by the relevant group companies in currencies other than their own functional currencies. The Group also manages its foreign exchange risk by performing regular reviews of the Group's net foreign exchange exposures and has entered into certain foreign exchange contracts to manage foreign exchange risks. As at 30th June 2025, the Group had certain outstanding forward foreign currency contracts to purchase USD (2024: purchase USD), details of which have been disclosed in Note 25. Certain of the Group's receivables, restricted bank deposits and cash and cash equivalents, trade and bills payables and borrowings were also denominated in foreign currencies, details of which have been disclosed in Notes 23, 26, 27 and 31. Since the HK\$ is pegged to USD, management are of the opinion that the exchange rate risk exposure arising from USD is relatively insignificant.

#### 3.1 財務風險因素(續)

##### (a) 外匯風險

本集團業務主要位於香港及中國內地，大部份交易以港元、人民幣及美元結算。倘日後商業交易或已確認資產及負債以非實體功能貨幣之貨幣計值，則外匯風險將會產生。本集團主要面對美元及人民幣的外匯風險。

管理層已訂立政策，要求集團公司管理與其功能貨幣有關的外匯風險。管理主要包括有關集團公司因以非公司功能貨幣銷售及購貨而引起之風險。本集團亦定期檢討外匯風險及使用遠期合約以管理外匯風險。於二零二五年六月三十日，本集團尚有若干未平倉的外幣(買美元)(二零二四年：買美元)遠期合約，詳情於附註25披露。本集團若干應收款、受限制的銀行存款及現金及現金等額、貿易應付款及應付票據及借貸以外幣計值，詳情於附註23、26、27及31披露。因為美元與港元掛鈎，管理層認為因美元引致的外匯風險相對並不重大。

#### 3.1 Financial risk factors (Continued)

##### (a) Foreign exchange risk (Continued)

At 30th June 2025, if HK\$ had weakened/strengthened by 5% against RMB, with all other variables held constant, post-tax profit for the year would have been HK\$1,437,000 higher/lower (2024: loss for the year HK\$1,473,000 lower/higher), mainly as a result of foreign exchange gains/losses on translation of foreign currency-denominated non-derivative financial assets and liabilities.

##### (b) Cash flow and fair value interest rate risk

The Group has no significant interest-bearing assets except for the cash at bank. The Group's exposure to changes in interest rates is mainly attributable to its borrowings. Borrowings carry at floating rates expose the Group to cash flow interest rate risk whereas those carry at fixed rates expose the Group to fair value interest rate risk.

The Group will review whether borrowings bearing fixed or floating rates should be drawn from time to time with reference to the trend of changes in interest rates.

##### (a) 外匯風險(續)

於二零二五年六月三十日，倘港元對人民幣貶值／升值百分之五且所有其他因素保持不變，則本年度稅後溢利將會增加／減少約1,437,000港元(二零二四年：稅後虧損減少／增加1,473,000港元)，主要是因換算以外幣列值的非衍生財務資產及負債而產生的匯兌收益／虧損。

##### (b) 現金流量及公允價值利率風險

本集團的收入及經營現金流量大致上不受市場利率變動的影響。本集團所涉及的利率變動風險主要來自借款。按浮動利率計息的借款使本集團面對現金流量風險，而按固定利率計息的借款則使本集團面對公允價值利率風險。

本集團會不時根據利率之變動趨勢以決定應以固定或浮動利率之附息貸款進行借貸。

##### (b) Cash flow and fair value interest rate risk (Continued)

As at 30th June 2025, if the interest rates had been 50 basis points higher/lower, with all other variables held constant, post-tax profit for the year will be HK\$354,000 lower/higher (2024: loss for the year HK\$278,000 higher/lower), mainly as a result of higher/lower interest expense on borrowings.

##### (c) Price risk

The Group is exposed to commodity price risk in relation to its plastic materials which is dependent on the oil price. The Group closely monitors the price of its raw materials in order to determine its pricing strategies.

The Group also exposed to price risk mainly arising from investments held by the Group and classified on the consolidated balance sheet as financial assets at fair value through profit or loss and financial asset at fair value through other comprehensive income. Management considers that their price risk are insignificant.

##### (b) 現金流量及公允價值利率風險(續)

於二零二五年六月三十日，倘利率已增加／減少五十個點子，而所有其他變素維持不變，則本年度稅後溢利將會減少／增加約354,000港元（二零二四年：稅後虧損增加／減少278,000港元）。該波動主要由於貸款產生的利息支出之增加／減少。

##### (c) 價格風險

本集團承受因原油價格引致的塑膠原料相關商品價格風險。本集團密切監察原材料價格變動以釐定其訂價策略。

本集團亦面對主要由本集團持有之投資（於綜合資產負債表按公允價值計入之金融資產）所產生之價格風險。管理層認為，其價格風險並不重大。

#### 3.1 Financial risk factors (Continued)

##### (d) Credit risk

Credit risk of the Group mainly arises from cash and cash equivalents and restricted bank deposits and financial institutions, as well as credit exposures to customers such as trade receivables and other counterparties. The carrying amounts of these balances in the consolidated balance sheet represents the Group's maximum exposure to credit risk in relation to its financial assets.

The Group has two types of financial assets that are subject to the expected credit loss model:

- Trade receivables; and
- Other financial assets at amortised cost.

Substantially all of the Group's cash at bank and the restricted bank deposits are deposited in major financial institutions located in Hong Kong and Chinese Mainland, which management believes are of high credit quality. The Group has a policy to limit the amount of credit exposure to any financial institution and management does not expect any losses arising from non-performance by these counterparties.

##### (d) 信貸風險

本集團並無高度集中的信貸風險。載於綜合資產負債表的銀行結餘、受限制的銀行存款、貿易應收款及應收票據、按金、其他應收款及可供出售財務資產的賬面值為本集團財務資產所承受的最大信貸風險。

本集團有兩類財務資產之新預期信貸虧損模型：

- 貿易應收款；及
- 按攤銷成本列賬之其他財務資產。

本集團大部分銀行結餘及受限制的銀行存款均存放於香港及中國內地的大型金融機構，管理層認為該等機構屬於高信貸質量。本集團採取限額政策以限制對任何金融機構的信貸風險且管理層並不預期會出現任何因該等金融機構不履約而產生的虧損。

##### (i) Trade receivables

The Group applies the HKFRS 9 simplified approach to measure expected credit losses which uses a lifetime expected loss allowance for all trade receivables and shared credit risk characteristics.

Trade receivables are written off when there is no reasonable expectation of recovery. Impairment losses on trade receivables are presented as reversal of loss allowance on trade receivables - net in consolidated income statement. Subsequent recoveries of amounts previously written off are credited against the same line item.

The expected loss rates are based on the payment profiles of customers and the corresponding historical credit losses experienced. The historical loss rates are adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables. With the increased risk from the volatility of economic climate in Chinese Mainland and Hong Kong, the Group has maintained a defined credit policy with tightened risk profile and applied prudent policies to manage its credit risk with its trade receivables that includes an ageing analysis of trade receivables is prepared on a regular basis and is closely monitored to minimise any credit risk associated with receivables.

貿易應收款於合理預期不可收回時撇銷。貿易應收款之減值虧損在經營溢利內呈列為減值虧損。其後收回此前撇銷之款項計入同一條目。

預期虧損率乃根據客戶的銷售付款情況及相應過往信貸虧損而釐定。過往虧損率乃經調整以反映影響客戶結算應收款之能力的宏觀經濟因素之現時及前瞻性資料。面對來自中國內地及香港的經濟氣候不確定性所引致的風險增加，本集團致力維持收緊風險評估及執行保守制度的特定貿易應收款信貸政策，定期制定貿易應收款之賬齡分析並密切監察以儘量減低應收款之信貸風險。

(ii) Other financial assets at amortised cost

Other financial assets at amortised cost include cash and cash equivalent, bills and other receivables. Management considered that these have a low credit risk and did not make any provision for these other financial assets at amortised cost based on the historical settlement pattern of these other financial assets and the forward-looking recoverability analysis of the counterparties.

As at 30th June 2025, the Company had provided guarantees in respect of banking facilities made available to its subsidiaries amounting to HK\$355,619,000 (2024: HK\$359,993,000). Credit risk in connection with such guarantees is considered to be minimal.

(e) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash and cash equivalents and the availability of funding through an adequate amount of committed credit facilities. Due to the dynamic nature of the underlying businesses, the Group aims to maintain flexibility in funding by keeping committed credit lines available.

The Group's primary cash requirements have been for additions of and upgrades on property, plant and equipment, settlement of borrowings, payment for trade and other payables, and payment for operating expenses. The Group mainly finances its working capital requirements through a combination of internal resources and borrowings.

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure it maintains sufficient cash balances and adequate credit facilities to meet its liquidity requirements in the short and long-term.

The Group measures and monitors its liquidity through the maintenance of prudent ratio regarding the liquidity structure of the overall assets, liabilities, loans and commitments of the Group. The Group also maintains a prudent level of liquid assets and committed banking facilities to ensure the availability of sufficient cash flows to meet any unexpected and material cash requirements in the ordinary course of business. As at 30th June 2025, the total banking facilities made available to the Group amounting to HK\$662,792,000 (2024: HK\$622,903,000) of which HK\$355,619,000 (2024: HK\$359,993,000) was being utilised by the Group.

Taking into account the Group's financial position, the Directors do not consider that it is probable that the banks will exercise their discretion to demand immediate repayment. The Directors believe that such borrowings will be repaid in accordance with the scheduled repayment dates set out in the loan agreements. As at 30th June 2025, total borrowing with repayment and demand clauses is HK\$400,045,000 (2024: HK\$385,873,000).

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group manages the capital structure and makes adjustments to it in the light of changes in economic conditions. In order to maintain or adjust the capital structure, the Group may adjust the dividend payments to shareholders, issue new shares or obtain new borrowings.

The Group also monitors capital on the basis of gearing ratio. This ratio is calculated as net debt divided by total capital. Net debt is calculated as total borrowings less cash and cash equivalents. Total capital is calculated as "equity", as shown in the consolidated balance sheet, plus net debt.

The quoted market price used for financial assets held by the Group is the current bid price. These instruments are included in level 1.

The fair value of financial instruments that are not traded in an active market (for example, over-the-counter derivatives) is determined by using valuation techniques. These valuation techniques maximise the use of observable market data where it is available and rely as little as possible on entity-specific estimates. If all significant inputs required to fair value an instrument are observable, the instrument is included in level 2.

If one or more of the inputs is not based on observable market data, the instrument is included in level 3.

#### 4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and judgement used in preparing financial statements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

##### (a) *Impairment of non-financial assets*

Non-financial assets including property, plant and equipment, right-of-use assets, leasehold land and land use rights and intangible assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amounts have been determined based on the higher of value-in-use calculations or fair value less costs to sell. These calculations require the use of judgements and estimates.

Management judgement is required in the area of asset impairment particularly in assessing: (i) whether an event has occurred that may indicate that the related asset values may not be recoverable; (ii) whether the carrying value of an asset can be supported by the recoverable amount, being the higher of fair value less costs to sell and value-in-use which are estimated based upon the continued use of the asset in the business; and (iii) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management in assessing impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test and as a result affect the Group's financial position and results of operations. If there is a significant adverse change in the projected performance and resulting future cash flow projections, it may be necessary to take an impairment charge to the consolidated income statement.

#### 4 重大會計估計及判斷

本集團將依據過往預備財務報表的經驗及其他因素包括按現況對日後事件的合理預測，不斷為估計及判斷作出評估。

本集團對未來作出估計所得之會計估計顧名思義甚少相等於相關實際結果。以下所述為有相當風險的估計及假設，可導致須於下個財政年度對資產與負債之賬面值作重大調整。

##### (a) *非財務資產減值*

非財務資產包括物業、廠房及設備，使用權資產和租賃土地及土地使用權和無形資產乃於有事件或情況變動顯示其賬面值可能不能收回時作減值檢討。可收回金額乃按其使用價值釐訂並考慮最近期市場資料之較高者及過往經驗。此等計算及估值須運用判斷及推算。

本集團於資產減值方面須作出判斷，特別是評估(i)有否出現可能資產價值收不回事件之跡象；(ii)資產賬面值是否獲得可收回金額支持，公允價值減可賣成本或其使用價值釐訂以較高者決定，而日後現金流量按持續使用資產評估；及(iii)編製現金流量預測所用合適主要假設包括現金流量預測是否以合適比率折算。管理層所選假設以評估減值包括現金流量預測所用折算率或增長率若有變化，可能對減值檢測所用現值淨額帶來重大影響，從而影響本集團財務狀況及營運成績。如預測表現及現金流量預測有重大逆轉改變，該減值需於綜合收益表列賬。

#### 4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS (Continued)

##### (b) Estimate of fair value of investment properties

The fair value of each investment property individually is determined at each balance sheet date by an independent professional valuer by reference to comparable market transactions and where appropriate on the basis of capitalisation of the passing rentals of the current leases based on the capitalisation rates including the outgoings. This methodology is based upon estimates of future results and a set of assumptions as to income and expenses of the property and future economic conditions. Details of the judgement and assumptions have been disclosed in Note 17.

##### (c) Estimate of provision for inventory

The Group writes down inventories to their net realisable value based on an assessment of the realisability of inventories. Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and variable selling expenses. These estimates are based on the current market condition and the historical experience of manufacturing and selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to severe industry cycle. Write-downs on inventories are recognised where events or changes in circumstances indicate that the value of the inventories may not be realised. The identification of write-downs requires the use of judgement and estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of inventories and write-downs of inventories is recognised in the period in which such estimate has been changed.

##### (b) 估計投資物業之公允價值

本集團根據存貨變現性之評估撇減存貨至可變現淨值。存貨可變現淨值指日常業務估計售價扣除估計銷售開支。有關估計根據現行市況及過往出售類似產品之經驗而作出。相關估計可能因客戶口味及競爭對手在行業激烈競爭中所採取措施而出現重大變動。一旦事件發生或情況改變顯示存貨價值可能未能變現時將被確認為撇減。識別撇減需要作出判斷及估計。當預期之金額與原定估計有差異時，則該差異將會於估計改變之期間內確認，並分別影響存貨之賬面值及存貨之撇減。

The Group is principally engaged in the manufacturing and trading of plastic materials, pigments, colorants, compounded plastic resins and engineering plastic products.

The chief operating decision-maker ("CODM") has been identified as the Executive Directors of the Company. Management has determined the operating segments based on the reports reviewed by the CODM that are used to assess performance and allocate resources. The CODM considers the business from the operations nature and the type of products perspective, including the trading of plastic materials ("Trading"), manufacturing and sale of colorants, pigments and compounded plastic resins ("Colorants"), manufacturing and sale of engineering plastic products ("Engineering plastics") and other corporate and business activities ("Others").

Each of the Group's operating segments represents a strategic business unit that is managed by different business unit leaders. Inter-segment transactions are entered into under the normal commercial terms and conditions that would also be available to unrelated third parties. Information provided to the CODM is measured in a manner consistent with that in the consolidated financial statements.

The CODM assesses the performance of the operating segments based on a measure of revenue and operating profit including corporate expenses, which is in a manner consistent with that of the consolidated financial statements.

Two subsidiaries in Dongguan and Xiamen which were certified as High and New Technology Enterprises and are entitled to a concessionary tax rate of 15% for three consecutive years from 2024 to 2026 and 2023 to 2025 respectively. These subsidiaries are entitled to re-apply for the preferential tax treatment when the preferential tax period expires.

Deferred income tax assets are recognised for tax losses carried forward to the extent that the realisation of the related tax benefit through future taxable profits is probable. At 30th June 2025, the Group had unrecognised tax losses to be carried forward against future taxable income amounted to approximately HK\$502,245,000 (2024: HK\$464,533,000). These tax losses have no expiry date except that approximately HK\$10,712,000 (2024: HK\$12,974,000) will expire from 2025 to 2029 (2024: 2025 to 2029). The potential deferred income tax assets in respect of these tax losses which have not been recognised amounted to approximately HK\$86,513,000 (2024: HK\$81,059,000).

As at 30th June 2025, deferred income tax has not been provided for in the consolidated financial statements in respect of temporary differences attributable to unremitted profits earned by certain Chinese Mainland subsidiaries of the Group amounting to approximately HK\$496,460,000 (2024: HK\$463,857,000) as the Group is able to control the timing of the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future. During the year ended 30th June 2025, deferred income tax amounted to approximately HK\$636,000 (2024: HK\$700,000) has been provided for in the consolidated financial statements in respect of withholding tax attributable to unremitted profit earned by a Chinese Mainland subsidiary of the Group that shall be distributed in the foreseeable future.

### 41.1 Principles of Consolidation

#### (a) Subsidiaries

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity where the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the group. They are deconsolidated from the date that control ceases.

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of profit or loss, statement of comprehensive income, statement of changes in equity and balance sheet respectively.

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

### 41.2 Segment information

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Executive Directors of the Company that make strategic decisions.

### 41.3 Foreign currency translation

#### (a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and the Group's presentation currency.

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated income statements.

Foreign exchange gains and losses that relate to borrowings are presented in the consolidated income statement within “finance income” or “finance costs”. All other foreign exchange gains and losses are presented in the consolidated income statement within “other (losses)/gains, net”.

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss and translation differences on non-monetary assets such as equities classified as fair value through other comprehensive income are recognised in other comprehensive income.

#### (c) Group companies

The results and financial position of all the group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (ii) income and expenses for each profit or loss account are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting exchange differences are recognised in consolidated other comprehensive income.

#### (c) 集團旗下公司

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, a disposal involving loss of joint control over a jointly controlled entity that includes a foreign operation, or a disposal involving loss of significant influence over an associate that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the equity holders of the Company are reclassified to consolidated income statements.

In the case of a partial disposal that does not result in the Group losing control over a subsidiary that includes a foreign operation, the proportionate share of accumulated exchange differences are reattributed to non-controlling interests and are not recognised in consolidated income statements.

### 41.4 Property, plant and equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation and accumulated impairment losses, if any. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the income statement during the financial period in which they are incurred.

#### (d) 境外經營的處置和部分處置

對於境外經營的處置(即處置集團在境外經營中的全部權益,或者處置涉及喪失對擁有境外經營的附屬公司的控制權,或涉及喪失對擁有境外經營的合營的共同控制權,或涉及喪失對擁有境外經營的聯營企業的控制權),就該項經營累計計入權益的歸屬於公司所有者的所有匯兌差額均重分類至綜合損益。

對於並不導致集團喪失對擁有境外經營的附屬公司的控制權的部分處置,集團在累計匯兌差額中的比例份額重新歸屬於非控制性權益並且不在綜合損益中確認。

### 41.4 物業、廠房及設備

物業、廠房及設備乃按歷史成本減累計折舊及累計減值虧損(如有)入賬。歷史成本包括收購有關項目直接應佔之開支。

其後之成本計入資產之賬面值,或僅在與該項目有關之未來經濟利益將流入本集團及該項目之成本可被可靠地計量時(如適用)確認為個別資產。所有其他維修及保養乃在產生之財務期間於收益表中列為開支。

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount of the relevant assets and are recognised in the consolidated income statements.

### 41.5 Investment properties

Investment properties, principally comprising leasehold land and buildings, is held for long-term rental yields or for capital appreciation or both, and that is not occupied by the Group. Land held under operating leases are accounted for as investment properties when the rest of the definition of an investment property is met. Investment property is measured initially at cost, including related transaction costs. Subsequent to initial recognition, investment property is measured at fair value.

Any gains and losses arising from changes in the fair value or disposal of an investment property are recognised in profit or loss in the period in which they arise.

After initial recognition, investment properties are carried at fair value, representing open market value determined at each reporting date by external valuers. Fair value is based on valuations carried out by external valuers. Changes in fair values are recorded in the consolidated income statements as valuation gain or loss in “other (losses)/gains, net”.

Subsequent expenditure is charged to the asset's carrying amount only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance costs are expensed in the consolidated profit or loss during the financial period in which they are incurred.

Gain or loss on disposal of an investment property is determined by comparing the proceeds and the carrying amount of the investment property and is recognised in the consolidated income statements.

### 41.6 Intangible assets - Technical know-how

Technical know-how comprises the acquired rights to use certain technologies for the manufacture of plastic products. Acquired technical know-how is capitalised on the basis of the costs incurred to acquire and bring to use. These costs are amortised over their estimated useful lives of five years.

### 41.7 Impairment of non-financial assets

Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

### 41.8 Financial assets

#### (a) Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

#### (b) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on the trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

#### (c) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss.

- Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in "other (losses)/gains, net" together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the consolidated income statement.

Dividends from such investments continue to be recognised in consolidated income statement as "other (losses)/gains, net" when the Group's right to receive payments is established.

#### (d) Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk. For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

### 41.9 Derivative financial instruments

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured at their fair values. The method of recognising the resulting gains or losses depends on whether the derivative is designated and qualified as a hedging instrument, and if so, the nature of the item being hedged. Assets and liabilities are classified as current if expected to be settled within 12 months; otherwise, they are classified as non-current.

As the Group's derivative financial instruments do not qualify for hedge accounting, changes in the fair value of these derivative financial instruments are recognised immediately in the consolidated profit or loss within "other (losses)/gains, net".

### 41.10 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average method. The cost of finished goods comprises raw materials, direct labour, other direct costs and related production overheads (based on normal operating capacity). It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

### 41.11 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents include cash in hand, deposits held at call with banks.

### **41.12 Financial liabilities**

Financial liabilities and equity instruments issued by the Group are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

Financial liabilities (including trade and bills payables) are initially measured at fair value, and are subsequently measured at amortised cost, using the effective interest method.

### **41.13 Share capital**

Ordinary shares are classified as equity. Incremental costs, net of tax, directly attributable to the issue of new shares or options are shown in equity as a deduction from the proceeds.

### **41.14 Borrowings**

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated profit or loss over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless the Group has a right to defer settlement of the liability for at least 12 months after the end of the reporting period.

Borrowing costs are recognised in profit or loss in the period in which they are incurred.

### 41.16 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

#### (a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. The Group measures its tax balances wither based on the most likely amount or the expected value, depending on which method provides a better predication of the resolution of the uncertainty.

#### (a) 當期所得稅

當期所得稅支出根據本公司的附屬公司及聯營經營及產生應課稅收入的國家於資產負債表日已頒佈或實質上已頒佈的稅務法例計算。管理層就適用稅務法例解釋所規限的情況定期評估報稅表的狀況。本集團根據最可能的金額或預期價值計量其稅項結餘，視乎何種方法可更好地預測不確定性的解決方案而定。

###### (b) Deferred income tax

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

The deferred tax liability in relation to investment property that is measured at fair value is determined assuming the property will be recovered entirely through sale.

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset where there is a legally enforceable right to offset current tax assets and liabilities and where the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

### 41.17 Employee benefits

#### (a) Pension obligations

The Group participates in several defined contribution retirement benefit schemes. A defined contribution scheme is a pension plan under which the Group pays contributions to publicly or privately administered pension plans on a mandatory, contractual or voluntary basis. The Group has no further legal or constructive obligations to pay further contributions once the contributions have been paid.

The Group participates in the mandatory provident fund scheme (the “MPF Scheme”) in Hong Kong. Under the MPF Scheme, the Group and its relevant employees makes monthly contributions to the scheme at 5% of the employee's relevant income with a maximum of HK\$1,500 per month, as appropriate, as defined in the Mandatory Provident Fund Scheme Ordinance. The contributions are fully and immediately vested in the employees.

The Group also contributes to certain defined contribution schemes for its employees in Chinese Mainland. Contributions are made by the Group on a monthly basis to those state-sponsored retirement plans based on a percentage of the relevant income of the relevant employees. The Group has no further obligations for the actual payment of pensions beyond its contributions. The state-sponsored retirement plans are responsible for the entire pension obligations payable to retired employees.

### 41.17 僱員福利

#### (a) 退休金承擔

本集團參與若干界定供款退休金計劃。界定供款計劃指本集團以強制、合約或自願基準向公開或私人管理的退休保險計劃作出供款之退休金計劃。本集團作出供款後，即無進一步付款責任。

本集團於香港參與強制性公積金計劃(「強積金計劃」)。根據強積金計劃，本集團及有關僱員均須按個別僱員各自根據強積金計劃界定的有關收入百分之五作強制性供款，上限為每月1,500港元(取適用者)。此等供款全數即時歸屬予僱員。

對中國內地的僱員，本集團亦向若干界定供款退休金計劃供款。本集團按有關僱員月薪的比率，每月向政府籌辦的多種定額供款退休金計劃供款。本集團除上述供款外，並不承擔任何退休福利責任。該等政府籌辦的多種定額供款退休金計劃將負責所有退休員工的退休金責任。

#### (a) Pension obligations (Continued)

Contributions made are recognised as employee benefits expenses when they are due and are not reduced by contribution forfeited by those relevant employees who leave the scheme prior to vesting fully in the contributions. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

#### (b) Employee leave entitlements

Employee entitlements to annual leaves are recognised when they accrue to employees. A provision is made for the estimated liabilities for annual leaves as a result of services rendered by employees up to the balance sheet date. Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

#### (c) Long service payments

The Group's net obligation in respect of long service payments to its employees upon termination of their employment or retirement when the employees fulfil certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefit that employees have earned in return for their service in the current and prior periods.

供款在應付時確認為僱員福利開支，且不可由全數歸屬供款前離開計劃的僱員所放棄的供款而減少。預付供款按照現金退款或可減少未來付款而確認為資產。

僱員年假之權利於僱員應享有時確認。估計截至結算日因僱員提供服務而結欠之年假已予撥備。僱員之病假及分娩假期不作確認，直至僱員正式休假為止。

#### (d) Share-based compensation

The Group operates an equity-settled, share-based compensation plan (the “Share Option Scheme”). The fair value of the employee services received in exchange for the grant of the options is recognised as an expense. The total amount to be expensed is determined by reference to the fair value of the options granted, including any market performance conditions; excluding the impact of any service and non-market performance vesting conditions; and including the impact of any non-vesting conditions.

Non-market performance and service conditions are included in assumptions about the number of options that are expected to vest. The total expense is recognised over the vesting period, which is the period over which all of the specified performance and service conditions are to be satisfied. At each balance sheet date, the entity revises its estimates of the number of options that are expected to vest based on the non-market vesting conditions. It recognises the impact of the revision of original estimates, if any, in the income statement, with a corresponding adjustment to equity.

The proceeds received net of any directly attributable transaction costs are credited to share capital (nominal value) and share premium when the options are exercised.

Under the terms of the existing Share Option Scheme of the Group, the Directors may, at their discretion, invite eligible participants to take up share options to subscribe for the shares of the Company subject to the terms and conditions stipulated therein. No share options were granted or exercised during the year. As at 30th June 2025 and 2024, there is no share option outstanding.

#### (e) Bonus entitlements

The expected cost of bonus payments is recognised as a liability when the Group has a present legal or constructive obligation as a result of services rendered by employees and a reliable estimate of the obligation can be made. Liabilities of bonus plan are expected to be settled within twelve months and are measured at the amounts expected to be paid when they are settled.

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

### 41.19 Leases

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- the exercise price of a purchase option if the lessee is reasonably certain to exercise that option; and
- payments of penalties for terminating the lease, if the lease term reflects the lessee exercising that option.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability;
- any lease payments made at or before the commencement date less any lease incentives received;
- any initial direct costs; and
- restoration costs.

### 41.20 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

### 41.21 Interest income

Interest income is recognised on a time-proportion basis using the effective interest method.

### 41.23 Losses per share

#### (i) Basic losses per share

Basic loss per share is calculated by dividing:

- The loss attributable to equity holders of the Company, excluding any costs of servicing equity other than ordinary shares; and
- by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year and excluding treasury shares.

#### (ii) Diluted loss per share

Diluted loss per share adjusts the figures used in determination of basic loss per share to take into account:

- the after-income tax effect of interest and other financing costs associated with dilutive potential ordinary shares, and

the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.
