#### NOTICE OF ANNUAL GENERAL MEETING

#### 1. INTRODUCTION

The primary purposes of this circular are to provide you with information regarding the resolutions to be proposed at the Annual General Meeting and to give you notice of the Annual

General Meeting. Resolutions to be proposed at the Annual General Meeting include ordinary resolutions on the grant of the Issue Mandate and the Repurchase Mandate, extension of general mandate to issue Shares and re-election of Directors, termination of Existing Share Option Scheme and adoption of New Share Option Scheme, and a special resolution on the Proposed Amendments and adoption of the New Bye-Laws.

Under the Listing Rules, the Company is required to provide you with information reasonably necessary to enable you to make an informed decision as to whether to vote for or against the resolutions to be proposed at the Annual General Meeting. This circular is also prepared for such purpose.

# 2. GRANT OF ISSUE MANDATE AND REPURCHASE MANDATE AND EXTENSION OF ISSUE MANDATE

At the annual general meeting of the Company held on 18th November 2021, the Directors were granted an issue mandate to allot, issue and deal with Shares in the capital of the Company and a repurchase mandate to repurchase Shares on the Stock Exchange. These general mandates will expire at the conclusion of the Annual General Meeting. At the Annual General Meeting, separate ordinary resolutions will be proposed to renew the general mandates given to the Directors (i) to exercise the power of the Company to allot, issue and otherwise deal with Shares not exceeding 20% of the aggregate number of the issued Shares at the date of passing of the relevant resolution; (ii) to exercise the power of the Company to repurchase issued and fully paid Shares on the Stock Exchange not exceeding 10% of the aggregate number of the issued Shares at the date of the passing of the relevant resolution; (iii) to extend the general mandate granted to the Directors to allot, issue and deal with additional Shares as mentioned in paragraph (i) above by the amount representing the aggregate number of the Shares repurchased by the Company under the Repurchase Mandate.

The Repurchase Mandate allows the Company to make or agree to make repurchases only during the period ending on the earliest of (a) the date of the next annual general meeting; (b) the date by which the next annual general meeting of the Company is required to be held by law or by its Bye-Laws; or (c) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

As at the Latest Practicable Date, the issued share capital of the Company comprised 369,200,000 Shares. Assuming that there is no change in the issued share capital of the Company between the period from the Latest Practicable Date to the date of passing the relevant resolutions, the maximum number of Shares which may be issued pursuant to the Issue Mandate will be 73,840,000 Shares and the maximum number of Shares which may be repurchased pursuant to the Repurchase Mandate will be 36,920,000 Shares on the date of passing the relevant resolutions.

To facilitate future allotment and issue of Shares by the Directors on behalf of the Company, the Directors will seek approval of the Shareholders for the grant of the Issue Mandate and the Repurchase Mandate. The Directors have no immediate plans to allot and issue any new Shares other than such Shares which may fall to be issued upon the exercise of any options granted under the share option schemes of the Company.

The explanatory statement required by the Listing Rules to be included in this circular concerning the Repurchase Mandate is set out in Appendix I to this circular.

#### 3. RETIREMENT AND RE-ELECTION OF DIRECTORS

Pursuant to Bye-law 87 of the Bye-laws, at each annual general meeting, one-third of the Directors, who have been longest in office since their last election, for the time being shall retire from office by rotation such that each Director will be subject to retirement by rotation at least once every three years at the annual general meeting. Mr. Hui Sai Chung, Mr. Hui Man Wai and Mr. Yu Chi Kwong will retire from office as Directors by rotation. They are eligible and will offer themselves for re-election as Directors at the Annual General Meeting.

#### Retirement of INED

Mr. Yu Chi Kwong ("Mr. Yu") was appointed to be an INED of the Company on 1st April 2020.

When identifying suitable candidates for directorships, the nomination committee of the Company carries out the selection process by making reference to the skills, experience, background, professional knowledge, personal integrity and time commitments of the proposed candidates, and also the Company's needs and other relevant statutory requirements and regulations required for the positions. All candidates must be able to meet the standards as set forth in Rules 3.08 and 3.09 of the Listing Rules. A candidate who is to be appointed as an independent non-executive Director should also meet the independence criteria set out in Rule 3.13 of the Listing Rules. Qualified candidates will then be recommended to the Board for approval. Mr. Yu is an existing independent non-executive Director of the Company, being eligible for re-election at the AGM. He has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules.

Mr. Yu does not hold any listed company's directorships. The Nomination Committee considers that Mr. Yu is able to devote sufficient time to the Board of the Company. Therefore, the Board, with the recommendations of the Nomination Committee, has nominated Mr. Yu for re-election as an INED at the AGM.

Biographical details of the retiring Directors who are proposed to be re-elected at the Annual General Meeting are set out in Appendix II to this circular.

# 4. TERMINATION OF EXISTING SHARE OPTION SCHEME AND ADOPTION OF NEW SHARE OPTION SCHEME

#### A. The Existing Share Option Scheme and the New Share Option Scheme

The Existing Share Option Scheme was adopted by a resolution duly passed by the Shareholders on 22nd November 2012. Under the Existing Share Option Scheme, the Directors were authorised to grant to any Eligible Participant the options to subscribe for Shares as incentives or rewards for their contribution to the Company and its subsidiaries. As the Existing Share Option Scheme is due to expire on 21st November 2022, in order to enable the continuity of the share option scheme of the Company, the Company proposes to terminate the Existing Share Option Scheme and adopt the New Share Option Scheme. An ordinary resolution will be proposed at the Annual General Meeting to approve the termination of the Existing Share Option Scheme and the adoption of the New Share Option Scheme. So far as the Directors are aware, no Shareholder is prohibited from voting in respect of such resolution.

It is proposed that subject to the approval of the Shareholders for the adoption of the New Share Option Scheme, the Existing Share Option Scheme will be terminated upon the adoption of the New Share Option Scheme after all conditions precedent as referred to under the paragraph headed "Conditions of the adoption of the New Share Option Scheme" have been fulfilled. Operation of the New Share Option Scheme will commence after all the conditions precedent as referred to under the paragraph headed "Conditions of the adoption of the New Share Option Scheme" have been fulfilled. A summary of the principal terms of the rules of the New Share Option Scheme is set out in Appendix III to this circular.

The New Share Option Scheme does not specify a performance target which must be achieved before an Option can be exercised. However, the Board may, at its discretion, fix the vesting period of the Options which shall not be less than 12 months, any performance targets that must be achieved and/or any other conditions (including the Exercise Price) that must be fulfilled before an Option can be exercised. This discretion, coupled with the power of the Board to impose any performance target as it considers appropriate before any Option can be exercised, enables the Group to provide incentives to the Eligible Participants to use their best endeavours in assisting the growth and development of the Group. Save for (i) updating the definition of qualifying grantee to include only Eligible Participants; and (ii) other necessary modifications and/or amendments to reflect the current provisions of the Listing Rules and the provisions of the Listing Rules to be effective on 1 January 2023 and for clarity and consistency with other provisions of the New Share Option Scheme where it is considered desirable, no other material amendments have been made to the New Share Option Scheme.

The Exercise Price of Options granted under the New Share Option Scheme shall be a price solely determined by the Board subject to such minimum amount as set out in the rules of the New Share Option Scheme, and the Board may specify in the offer letter granting the Options the performance targets that need to be achieved by an Eligible Participant as well as the vesting period of the Option which shall be not less than 12 months before an Option can be exercised. The Directors believe that in providing the Board with the discretion to determine the Exercise Price and basis of eligibility of Eligible Participants, set performance targets, prescribe a vesting period before Options can be exercised and impose clawback mechanism, the Group will be in a better position to

attract and retain valuable human resources as well as to achieve the purposes of the New Share Option Scheme. Unless otherwise determined by the Board, there are no performance targets under the New Share Option Scheme which must be achieved but the vesting period to be determined by the Board shall be not less than 12 months. The Company does not at present intend to appoint a trustee to the New Share Option Scheme.

As at the Latest Practicable Date, the Company did not have any outstanding share options granted pursuant to the Existing Share Option Scheme which remained outstanding and not exercised. Other than the Existing Share Option Scheme, the Company currently does not maintain any other share option scheme. At present and up to the date on which the New Share Option Scheme comes into effect, the Company has no intention to grant options under the Existing Share Option Scheme. The Company has no existing plan to grant Options to any of the Eligible Participants after the adoption of the New Share Option Scheme.

Upon termination of the Existing Share Option Scheme, no further options may be granted but in all other respects the provisions of the Existing Share Option Scheme shall remain in full force and effect. Therefore, the adoption of the New Share Option Scheme will not in any event affect the terms of the grant of such outstanding options that have already been granted under the Existing Share Option Scheme and the above outstanding options granted under the Existing Share Option Scheme shall continue to be valid and subject to the provisions of the Existing Share Option Scheme.

As at the Latest Practicable Date, the number of Shares in issue is 369,200,000 Shares. Assuming that there is no change in the number of issued Shares between the period from the Latest Practicable Date and the date of Annual General Meeting, the maximum number of Shares that may be issued upon exercise of all Options to be granted under the New Share Option Scheme and any other share option scheme of the Company (if any) will be 36,920,000 Shares, being approximately 10% of the total number of issued Shares.

No Shareholder is required to abstain from voting on the termination of the Existing Share Option Scheme and the adoption of the New Share Option Scheme.

#### B. Conditions of the adoption of the New Share Option Scheme

The adoption of the New Share Option Scheme is conditional upon (i) the passing of an ordinary resolution by the Shareholders at general meeting approving the termination of the Existing Share Option Scheme and the adoption of the New Share Option Scheme and authorising the Directors to grant Options to subscribe for Shares thereunder and to allot, issue and deal with Shares pursuant to the exercise of any Options granted under the New Share Option Scheme; and (ii) the Listing Committee of the Stock Exchange granting approval of the listing of, and permission to deal in, any Shares to be issued pursuant to the exercise of any Options granted under the New Share Option Scheme.

Application will be made to the Stock Exchange for the approval of the listing of, and permission to deal in, the Shares to be issued pursuant to the exercise of Options granted under the New Share Option Scheme.

#### C. Principal terms of the New Share Option Scheme

A summary of the principal terms of the New Share Option Scheme which is proposed to be adopted by the Company at the Annual General Meeting is set out in Appendix III to this circular. A copy of the rules of the New Share Option Scheme will be available for inspection at the principal place of business in Hong Kong at Unit 3, 6th Floor, Hopeful Factory Centre, 10 Wo Shing Street, Fo Tan, New Territories, Hong Kong during normal business hours from the date of this circular up to and including the date of Annual General Meeting and adjournment thereof (as the case may be). A copy of the New Share Option Scheme will be published on the websites of HKExnews (https://www.hkexnews.hk) and the Company (https://www.nhh.com.hk) from 17th October 2022 and up to and including the date of the Annual General Meeting, and will also be available for inspection at the Annual General Meeting.

#### D. Value of all Options that can be granted under the New Share Option Scheme

The Directors consider that it is not appropriate to state the value of all Options that may be granted pursuant to the New Share Option Scheme as if they had been granted on the Latest Practicable Date, because the calculation of the value of the Options is based on a number of variables such as the exercise price, exercise period, interest rate, expected volatility and other relevant variables. As Options have not been granted under the New Share Option Scheme, certain variables are not available for calculating the value of the Options. The Directors believe that any calculation of the value of the Options as at the Latest Practicable Date based on a great number of speculative assumptions would not be meaningful and would be misleading to the Shareholders.

# 5. PROPOSED AMENDMENTS TO THE EXISTING BYE-LAWS AND ADOPTION OF THE NEW BYE-LAWS

The Board will propose at the Annual General Meeting a special resolution approving the Proposed Amendments and the adoption of the New Bye-Laws consolidating the Proposed Amendments, in order to, inter alia, (i) bring the Existing Bye-Laws in alignment with the Core Shareholder Protection Standards set out in Appendix 3 to the Listing Rules which took effect on 1st January 2022 and the applicable laws of Bermuda; (ii) allowing general meetings to be held as a physical meeting, an electronic meeting or a hybrid meeting where Shareholders may attend by electronic means in addition to physical attendance in person, and providing certain powers to the Board and the chairman of the meeting in relation thereto; and (iii) making other housekeeping amendments, including consequential amendments in line with the above amendments to the Existing Bye-Laws. In view of the number of Proposed Amendments, the Board proposes to adopt the New Bye-Laws in substitution for, and to the exclusion of, the Existing Bye-Laws.

The major changes brought about by the Proposed Amendments are summarized below:

1. to insert the definitions of "announcement", "close associates", "electronic communication", "electronic meeting", "hybrid meeting", "Meeting Location", "physical meeting", "Principal Meeting Place" and "substantial shareholder", and make corresponding changes to the relevant provisions of the New Bye-Laws;

- 2. to update the provision regarding the inspection of the principal register and branch register of members shall be opened to the members of the public at specific time;
- 3. to provide that the Company shall hold an annual general meeting in each financial year and such annual general meeting must be held within six months after the end of the Company's financial year;
- 4. to provide that an annual general meeting of the Company shall be called by notice of not less than twenty-one clear days. All other general meetings (including a special general meeting) must be called by notice of not less than fourteen clear days but if permitted by the Listing Rules, a general meeting may be called by shorter notice if it is so agreed;
- 5. to include additional details to be specified in a notice of general meeting in light of allowing general meetings to be held at one or more meeting locations, or as a hybrid meeting or an electronic meeting;
- 6. to provide that the chairman of the general meeting may, with the consent of the meeting at which a quorum is present, adjourn the meeting from time to time (or indefinitely), from place to place(s) and/or from one form to another (a physical meeting, a hybrid meeting or an electronic meeting);
- 7. to provide that general meetings may be held as a physical meeting in any part of the world and at one or more locations, or as a hybrid meeting or an electronic meeting, and the powers of the Board and the chairman of the meeting in relation to conduct of such meeting;
- 8. to provide that, where the Directors, in their absolute discretion, consider that it is inappropriate, impracticable, unreasonable or undesirable for any reason to hold a general meeting as specified in the notice calling for such meeting, they may change or postpone the meeting to another date, time, place, change the electronic facilities and/or change the form of the meeting (a physical meeting, an electronic meeting or a hybrid meeting) without approval from the Shareholders;
- 9. to provide that votes (whether on a show of hands or by way of poll) may be cast by such means, electronic or otherwise, as the Directors or the chairman of the meeting may determine;
- 10. to provide that all Members shall have the right to (i) speak at a general meeting of the Company; and (ii) vote at a general meeting of the Company, except where any Member is required, by the Listing Rules, to abstain from voting to approve the matter under consideration:

- 11. to provide that where the Company has knowledge that any Member is, under the Listing Rules, required to abstain from voting on any particular resolution of the Company or restricted to voting only for or only against any particular resolution of the Company, any votes cast by or on behalf of such Member in contravention of such requirement or restriction shall not be counted;
- 12. to clarify that any Director appointed by the Board to fill a casual vacancy on the Board or as an addition to the existing Board shall hold office until the first annual general meeting of the Company after his appointment and shall then be eligible for re-election;
- 13. to provide the Board with the power to capitalise reserves of the Company to pay up in full Shares to be issued pursuant to a share incentive scheme or employee benefit scheme that has been adopted or approved by the Shareholders;
- 14. to provide that the Members may, at any general meeting convened and held in accordance with the New Bye-laws, by extraordinary resolution (by a majority of not less than two thirds of votes) remove the auditors of the Company ("Auditors") at any time before the expiration of their term of office;
- 15. to update the provision regarding the appointment of the Auditors by the Board to fill any casual vacancy therein that any such Auditor appointed shall hold office until the first annual general meeting of the Company after his appointment and shall then be subject to appointment by the Shareholders;
- 16. to make other house-keeping amendments and making consequential amendments in line with the above amendments to the Existing Bye-Laws; and
- 17. to make other amendments to update or clarify provisions where the Board consider desirable in accordance with or better align with the wording in the applicable laws of Bermuda and the Listing Rules.

Further particulars of the Proposed Amendments is set out in Appendix IV to this circular.

The legal adviser to the Company as to Hong Kong laws has confirmed that the Proposed Amendments comply with the requirements of the Listing Rules, and the legal adviser to the Company as to Bermuda laws has confirmed that the Proposed Amendments do not violate Bermuda laws.

The Company confirms that there is nothing unusual about the Proposed Amendments. Shareholders are advised that the New Bye-Laws are written in English only and there is no official Chinese translation. The Chinese translation of the New Bye-Laws is provided for reference only. In case of any discrepancy or inconsistency, the English version shall prevail.

#### 6. ACTIONS TO BE TAKEN

At the Annual General Meeting, resolutions will be proposed to approve, among other matters, the following:

- (a) the grant of the Issue Mandate;
- (b) the grant of the Repurchase Mandate;
- (c) the extension of the Issue Mandate;
- (d) the re-election of Directors;
- (e) the termination of Existing Share Option Scheme and the adoption of New Share Option Scheme; and
- (f) the Proposed Amendments and adoption of the New Bye-Laws.

Whether or not you are able to attend the Annual General Meeting in person, you are requested to complete and return the form of proxy in accordance with the instructions printed thereon as soon as possible and, in any event not later than 48 hours before the time for the Annual General Meeting or any adjournment thereof to the Company's branch share registrar in Hong Kong, Union Registrars Limited at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong. Completion and return of the form of proxy will not preclude you from attending and voting in person at the Annual General Meeting or any adjournment thereof should you so wish and in such event, the form of proxy shall be deemed to be revoked.

#### 7. VOTING BY POLL

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Accordingly all resolutions to be proposed at the Annual General Meeting shall be voted by poll.

#### 8. RECOMMENDATION

The Directors consider that (a) the Issue Mandate, (b) the Repurchase Mandate, (c) the extension of the Issue Mandate, (d) the re-election of the Directors, (e) the termination of Existing Share Option Scheme and adoption of New Share Option Scheme and (f) the Proposed Amendments and adoption of the New Bye-Laws are in the best interests of the Company and the Shareholders. The Directors therefore recommend the Shareholders to vote in favour of all the resolutions as set out in the AGM Notice on pages 92 to 98 of this circular.

#### 9. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

#### APPENDIX I — EXPLANATORY STATEMENT

This appendix serves as an explanatory statement, as required by the Listing Rules, to provide the requisite information to enable you to make an informed decision whether to vote for or against the resolution to approve the grant of the Repurchase Mandate to the Directors.

#### Listing Rules relating to the repurchase of securities

The Listing Rules permit companies whose primary listings are on the Stock Exchange to repurchase their securities on the Stock Exchange subject to certain restrictions, the most important of which is summarised below. The Company is empowered by its memorandum of association and the Bye-Laws to repurchase its own securities.

#### Share capital

As at the Latest Practicable Date, the issued share capital of the Company comprised 369,200,000 Shares. Subject to the passing of the proposed resolution for the grant of the Repurchase Mandate and on the basis that no Shares are allotted and issued or repurchased by the Company prior to the Annual General Meeting, the Company will be allowed under the Repurchase Mandate to repurchase up to a maximum of 36,920,000 Shares.

#### Reasons for repurchase

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders. An exercise of the Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made if the Directors believe that such repurchases will benefit the Company and its Shareholders.

#### Funding of repurchases

In repurchasing securities, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and the Bye-Laws of the Company, the Listing Rules and the applicable laws of Bermuda.

Taking into account the current working capital position of the Group, the Directors consider that, if the Repurchase Mandate were to be exercised in full, it might have a material adverse effect on the working capital and/or the gearing position of the Group as compared with its position as at 30th June 2022. However, the Directors do not intend to make any repurchases to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing position of the Group, which in the opinion of the Directors, are from time to time appropriate for the Group.

#### Disclosure of interests and minimum public holding

None of the Directors or, to the best of their knowledge, having made all reasonable enquiries, their associates (as defined in the Listing Rules), have any present intention to sell to the Company or its subsidiaries any Shares if the Repurchase Mandate is approved at the Annual General Meeting and exercised.

The Directors have undertaken to the Stock Exchange that they will exercise the power of the Company to make purchases of the Shares pursuant to the Repurchase Mandate in accordance with the Listing Rules, applicable laws of Bermuda and the regulations set out in the memorandum of association of the Company and the Bye-Laws.

If a Shareholder's proportionate interest in the voting rights of the Company increases on the Company exercising its powers to repurchase Shares pursuant to the Repurchase Mandate, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert (within the meaning of the Takeovers Code) could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with rules 26 and 32 of the Takeovers Code.

#### APPENDIX I — EXPLANATORY STATEMENT

As at the Latest Practicable Date, to the best knowledge and belief of the Directors, each of (1) Mr. Hui Sai Chung; and (2) Mr. Hui Kwok Kwong were interested in approximately 60.36% and 59.22% of the then issued share capital of the Company. Each of Mr. Hui Sai Chung and Mr. Hui Kwok Kwong holds 45.10% interest in Good Benefit Limited, a company which holds approximately 53.28% of the issued capital of the Company. Mr. Hui Sai Chung and Mr. Hui Kwok Kwong are deemed to be holding 53.28% interest in the Company indirectly through Good Benefit Limited under the SF Ordinance. On the basis that 369,200,000 Shares were in issue as at the Latest Practicable Date and assuming no further issue nor repurchase of Shares prior to the date of the Annual General Meeting, if the Repurchase Mandate were exercised in full, the percentage interests in the capital of the Company held by each of (1) Mr. Hui Sai Chung; and (2) Mr. Hui Kwok Kwong would increase to approximately 67.07% and 65.80% respectively of the issued share capital of the Company.

On the basis of the current percentage interests in the Company of such persons, an exercise of the Repurchase Mandate in full will not result in any of such persons becoming obliged to make a mandatory offer under the Takeovers Code.

The Directors have no intention to exercise the Repurchase Mandate to such an extent that it will result in less than 25% of the Shares being held by the public.

As at the Latest Practicable Date, no connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she/it has a present intention to sell any securities of the Company nor has such connected person undertaken not to sell any of the securities held by him/her/it to the Company in the event that the Repurchase Mandate is granted.

#### Securities repurchase made by the Company

The Company had not purchased any of the Shares (whether on the Stock Exchange or otherwise) during the six months preceding the Latest Practicable Date.

#### Mr. Hui Sai Chung

He is also responsible for the marketing and sales functions of the Group. He has more than 52 years' experience in the plastics industry.

Mr. Hui Sai Chung has entered into a service contract with the Company for a term of three years commencing on 1st December 2021. The emoluments of Mr. Hui Sai Chung are determined by reference to his duties and responsibilities, individual performances, the financial results of the Group, and the prevailing market benchmark. The emoluments (including director's fee and bonus payment) of Mr. Hui Sai Chung for the year ended 30th June 2022 is HK\$5,266,450. For the financial year ending 30th June 2023, Mr. Hui Sai Chung will be entitled to a remuneration of approximately HK\$5,266,450 per annum and discretionary bonus as may be decided by the Board having regard to the Group's performance and profitability. Mr. Hui Sai Chung is subject to retirement by rotation and re-election at annual general meetings of the Company in accordance with the Bye-Laws which requires one third of the Directors shall retire from office by rotation and shall be eligible for re-election.

#### Mr. Hui Man Wai

Mr. Hui Man Wai, aged 52, is the Business Development Manager of Dongguan Coltec Plastic Trading Company Limited and is responsible for market exploration and business development of Colour Masterbatches and Functional Masterbatches for plastic industries in Southern and South Western China. He holds a Master degree of Business and Administration (Executive) from City University of Hong Kong. Mr. Hui joined the Group in 1997 and has over 25 years' experience in business management, sales & marketing. He is the son of Mr. Hui Kwok Kwong (who is the Deputy Chairman and Managing Director of the Company).

Mr. Hui Man Wai has entered into a service contract with the Company for a term of three years commencing on 1st December 2021. The emoluments of Mr. Hui Man Wai are determined by reference to his duties and responsibilities, individual performances, the financial results of the Group, and the prevailing market benchmark. The emoluments (including director's fee and bonus payment) of Mr. Hui Man Wai for the year ended 30th June 2022 is HK\$982,020. For the financial year ending 30th June 2023, Mr. Hui Man Wai will be entitled to a remuneration of approximately HK\$982,020 per annum and discretionary bonus as may be decided by the Board having regard to the Group's performance and profitability. Mr. Hui Man Wai is subject to retirement by rotation and re-election at annual general meetings of the Company in accordance with the Bye-Laws which requires one third of the Directors shall retire from office by rotation and shall be eligible for re-election.

Independent Non-executive Director

#### Mr. Yu Chi Kwong ("Mr. Yu")

Mr. Yu, aged 54, has been an Independent Non-executive Director of the Company since 1st April 2020. He is also a member of each of the Audit Committee, the Corporate Governance Committee, the Remuneration Committee and the Nomination Committee of the Company. Mr. Yu is the Business Manager of an international insurance company in Hong Kong. He holds a Bachelor degree of Science with Honours in Applied Chemistry from Hong Kong Baptist University and a Master degree of Business Administration from the University of South Australia. He is also a Fellow Chartered Financial Practitioner of the Asia Pacific Financial Services Association. Mr. Yu started the career in plastics industry and had accumulated more than 20 years' experiences in the industry, which included holding managerial positions in various multinational companies for plastic materials sales and product marketing in Hong Kong and Mainland China.

Pursuant to an appointment letter entered into between Mr. Yu and the Company, Mr. Yu was appointed as an independent non-executive Director for a term of twenty seven months from 1st April 2021. The emoluments of Mr. Yu are determined by reference to his duties and responsibilities, individual performances, the financial results of the Group, and the prevailing market benchmark. The emoluments (including director's fee and bonus payment) of Mr. Yu for the year ended 30th June 2022 is HK\$200,000. For the financial year ending 30th June 2023, Mr. Yu will be entitled to a remuneration of approximately HK\$200,000 per annum. Mr. Yu is subject to retirement by rotation and re-election at annual general meetings of the Company in accordance with the Bye-Laws which requires one third of the Directors shall retire from office by rotation and shall be eligible for re-election.

#### APPENDIX III — PRINCIPAL TERMS OF THE NEW SHARE OPTION SCHEME

Set out below is a summary of the principal terms and conditions of the New Share Option Scheme to provide sufficient information to the Shareholders for their consideration of the New Share Option Scheme proposed to be adopted at the Annual General Meeting.

#### (1) PURPOSE, DURATION AND ADMINISTRATION OF THE SCHEME

The purpose of the New Share Option Scheme is to enable the Group to grant Options to Eligible Participants as incentives or rewards for their contribution to the Group.

Subject to the terms of the New Share Option Scheme, the New Share Option Scheme shall be valid and effective for a period of 10 years commencing on the Adoption Date, after which period no further Options will be offered or granted but the provisions of the New Share Option Scheme shall remain in full force and effect in all other respects.

#### (2) WHO MAY JOIN

The Board may, at its absolute discretion, invite any person belonging to any of the following classes of participants (the "Eligible Participants"), to take up Options to subscribe for Shares:

- (a) any Eligible Employee; and
- (b) any non-executive directors (but excluding independent non-executive directors) of the Company or any of our subsidiaries.

The basis of eligibility of any of the above class of Eligible Participants to the grant of any Options shall be determined by the Board from time to time on the basis of their contribution to the development and growth of the Group.

#### (3) MAXIMUM NUMBER OF SHARES

- (a) The total number of Shares which may be allotted and issued upon exercise of all Options (excluding, for this purpose, options which have lapsed in accordance with the terms of the New Share Option Scheme and any other share option scheme of the Group) to be granted under the New Share Option Scheme and any other share option scheme of the Group must not in aggregate exceed 10% of the Shares in issue as at the Adoption Date (the "General Mandate Limit"). Assuming that there is no change in the Shares in issue between the period from the Latest Practicable Date and the date of passing the relevant resolution, the maximum number of Shares may be issued upon exercise of the Options granted under the General Mandate Limit is 36,920,000 Shares.
- (b) Without prejudice to (c) below, the Company may seek approval of the Shareholders at general meeting to refresh the General Mandate Limit under the New Share Option Scheme after three years from the date of Shareholders' approval for the last refreshment (or the Adoption Date), provided that the total number of Shares which may be allotted and issued upon exercise of all Options to be granted under the New Share Option Scheme and any

other share options scheme of the Group must not exceed 10% of the Shares in issue as at the date of approval of the limit and for the purpose of calculating the refreshed limit, options (including those outstanding, cancelled, lapsed or exercised in accordance with the New Share Option Scheme and any other share option scheme of the Group) previously granted under the New Share Option Scheme and any other share option scheme of the Group will not be counted.

(c) Without prejudice to (b) above, the Company may seek separate Shareholders' approval at general meeting to grant Options beyond the General Mandate Limit or, if applicable, the extended limit referred to in (b) above to Eligible Participants specifically identified by the Company before such approval is sought.

#### (4) MAXIMUM ENTITLEMENT OF EACH PARTICIPANT

The total number of Shares issued and which may fall to be issued upon exercise of the Options and the options granted under any other share option scheme of the Group (including both exercised or outstanding options) to each Grantee in any 12-month period shall not exceed 1% of the Shares in issue for the time being. Where any further grant of Options to a Grantee under the New Share Option Scheme would result in the Shares issued and to be issued upon exercise of all options granted and proposed to be granted to such person (including exercised, cancelled and outstanding options) under the New Share Option Scheme and any other share option schemes of the Group in the 12-month period up to and including the date of such further grant representing in aggregate over 1% of the Shares in issue, such further grant must be separately approved by Shareholders at general meeting of the Company with such Grantee and his Close Associates (or his Associates if the Grantee is a Connected Person) abstaining from voting.

#### (5) GRANT OF OPTIONS TO CONNECTED PERSONS

- (a) Any grant of Options under the New Share Option Scheme to any director, chief executive or substantial shareholder of the Company, or any of their respective Associates must be approved by the independent non-executive Directors.
- (b) Where any grant of Options to a substantial Shareholder or any of their respective Associates or the Associates of independent non-executive Directors, would result in the Shares issued and to be issued upon exercise of all Options already granted and to be granted (including Options exercised, cancelled and outstanding) to such person in the 12-month period up to and including the date of such grant representing in aggregate over 0.1% of the Shares in issue for the time being, such further grant of Options must be approved by the Shareholders at general meeting. The Company shall send a circular to all Shareholders containing the information required under the Listing Rules. The Grantee, his Associates and all Core Connected Persons of the Company must abstain from voting at such general meeting, except that any Core Connected Person may vote against the relevant resolution at the general meeting provided that his intention to do so has been stated in the circular. Any vote taken at the meeting to approve the grant of such Options must be taken on a poll.

#### APPENDIX III — PRINCIPAL TERMS OF THE NEW SHARE OPTION SCHEME

- (c) For the purpose of seeking the approval of the Shareholders under paragraphs (5) (a) and (b), the Company must send a circular to the Shareholders containing the information:
  - (i) details of the number and terms (including the Option Period, performance targets (if any), basis of determination of Exercise Price and the rights attached to the Shares or the Option) of the Options to be granted to each such substantial Shareholder or any of their respective Associates or the Associates of independent non-executive Directors, which must be fixed before the Shareholders' meeting and the date of Board meeting for proposing such further grant should be taken as the date of grant for the purpose of calculating the Exercise Price;
  - (ii) the views of the independent non-executive Directors as to whether the terms of the grant are fair and reasonable and whether such grant is in the interests of the Company and the Shareholders as a whole, and their recommendation to the independent Shareholders as to voting; and
  - (iii) the information required under the Listing Rules.

#### (6) TIME OF ACCEPTANCE AND EXERCISE OF OPTION

An offer shall remain open for acceptance by the Eligible Participant concerned (and by no other person) for a period of up to 21 days from the Offer Date, provided that no such Offer shall be opened for acceptance after the 10th anniversary of the Adoption Date or after the New Share Option Scheme has been terminated in accordance with the provisions hereof.

An Option may be exercised in accordance with the terms of the New Share Option Scheme at any time during a period to be determined and notified by the Board to each Grantee, which period shall end in any event not later than 10 years from the date of grant of the Option subject to the provisions for early termination thereof. The vesting period for Options shall be determined by the Board and in any case, shall not be less than 12 months.

#### (7) PERFORMANCE TARGETS

Unless the Board otherwise determined and stated in the offer of the grant of Options to a Grantee, a Grantee is not required to achieve any performance targets before the exercise of an Option granted to him.

#### (8) EXERCISE PRICE FOR SHARES AND CONSIDERATION FOR THE OPTION

The Exercise Price for Shares under the New Share Option Scheme will be a price determined by the Board, but shall not be less than the highest of:

(a) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the Offer Date;

- (b) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the 5 Business Days immediately preceding the Offer Date; and
- (c) the nominal value of a Share on the Offer Date.

A nominal consideration of HK\$1 is payable on acceptance of the grant of an Option.

#### (9) RANKING OF SHARES

Shares to be allotted and issued upon the exercise of an Option will be subject to all the provisions of the bye-laws of the Company for the time being in force and will rank pari passu in all respects with the then existing fully paid Shares in issue on the date on which the Option is duly exercised or, if that date falls on a day when the register of members of the Company is closed, the first day of the re-opening of the register of members (the "Exercise Date") and accordingly will entitle the holders thereof to participate in all dividends or other distributions paid or made on or after the Exercise Date other than any dividend or other distribution previously declared or recommended or resolved to be paid or made if the record date therefor shall be before the Exercise Date. A Share allotted and issued upon the exercise of an Option shall not carry voting rights until the name of the Grantee has been duly entered on the register of members of the Company as the holder thereof.

#### (10) RESTRICTIONS ON THE TIME OF GRANT OF OPTIONS

For so long as the Shares are listed on the Stock Exchange, an Offer may not be made after inside information has occurred or a price sensitive matter has been the subject of a decision until such inside information has been announced in accordance with the requirements of the Listing Rules. In particular, during the period commencing 1 month immediately preceding the earlier of:

- (a) the date of the board meeting (as such date is first notified to the Stock Exchange in accordance with the Listing Rules) for the approval of the Company's results for any year, half-year, quarter or any other interim period (whether or not required under the Listing Rules); and
- (b) the deadline for the Company to publish an announcement of its results for any year, half-year, quarter or any other interim period (whether or not required under the Listing Rules),

and ending on the date of the results announcement, no Offer may be made.

The Board may not make any Offer to an Eligible Participant who is subject to the Model Code during the periods or times in which such Eligible Participant is prohibited from dealing in Shares pursuant to Model Code.

#### (11) PERIOD OF THE NEW SHARE OPTION SCHEME

The New Share Option Scheme will remain in force for a period of 10 years commencing on the Adoption Date.

#### (12) RIGHTS ON CEASING EMPLOYMENT

If the Grantee is an Eligible Employee and in the event of his ceasing to be an Eligible Employee for any reason other than death, ill-health or retirement in accordance with his contract of employment on one or more of the grounds specified in paragraph (14) below before exercising the Option in full, the Option (to the extent not already exercised) shall lapse on the date of cessation or termination and not be exercisable unless the Board otherwise determine in which event the Grantee may exercise the Option (to the extent not already exercised) in whole or in part in accordance with the provisions in the New Share Option Scheme within such period as the Board may determine following the date of such cessation or termination or, if any of the events referred to in paragraph (16) or (17) occur during such period, exercise the Option pursuant to paragraph (16) or (17) respectively. The date of cessation or termination as aforesaid shall be the last day on which the Grantee was actually at work with the Company or the relevant Subsidiary whether salary is paid in lieu of notice or not.

#### (13) RIGHTS ON DEATH, ILL-HEALTH OR RETIREMENT

If the Grantee is an Eligible Employee and in the event of his ceasing to be an Eligible Employee by reason of his death, ill-health or retirement in accordance with his contract of employment before exercising the Option in full, his Personal Representative(s), or, as appropriate, the Grantee may exercise the Option (to the extent not already exercised) in whole or in part in accordance with the provisions in the New Share Option Scheme within a period of 12 months following the date of cessation which date shall be the last day on which the Grantee was at work with the Company or the relevant Subsidiary whether salary is paid in lieu of notice or not, or such longer period as the Board may determine or, if any of the events referred to in paragraph (16) or (17) occur during such period, exercise the Option pursuant to paragraph (16) or (17) respectively.

#### (14) RIGHTS ON DISMISSAL

If the Grantee is an Eligible Employee and ceases to be an Eligible Employee by reason of a termination of his employment on the grounds that he has been guilty of persistent or serious misconduct, or has committed any act of bankruptcy or has become insolvent or has made any arrangements or composition with his creditors generally, or has been convicted of any criminal offence (other than an offence which in the opinion of the Board does not bring the Grantee or the Group into disrepute), his Option (to the extent not already exercised) shall lapse automatically and will not in any event be exercisable on or after the date of cessation to be an Eligible Employee.

#### (15) RIGHTS ON BREACH OF CONTRACT

If the Board shall at their absolute discretion determine that (i) the Grantee (other than an Eligible Employee) or his Associate has committed any breach of any contract entered into between such Grantee or his Associate on the one part and the Group on the other part; or (ii) that such Grantee has committed any act of bankruptcy or has become insolvent or is subject to any winding-up, liquidation or analogous proceedings or has made any arrangement or composition with his creditors generally; or (iii) such Grantee could no longer make any contribution to the growth and development of the Group by reason of the cessation of its relations with the Group or by any other reason whatsoever; the Option shall lapse as a result of any event referred to (i), (ii) or (iii) above.

#### (16) RIGHTS ON A GENERAL OFFER, A COMPROMISE OR ARRANGEMENT

If a general or partial offer, whether by way of take-over offer, share re-purchase offer, or scheme of arrangement or otherwise in like manner is made to all the holders of the Shares, or all such holders other than the offeror and/or any person controlled by the offeror and/or any person acting in association or concert with the offeror, the Company shall use all reasonable endeavours to procure that such offer is extended to all the Grantees on the same terms, mutatis mutandis, and assuming that they will become, by the exercise in full of the Options granted to them, Shareholders. If such offer becomes or is declared unconditional or such scheme of arrangement if formally proposed to Shareholders, the Grantee shall, notwithstanding any other terms on which his Options were granted, be entitled to exercise the Option (to the extent not already exercised) to its full extent or to the extent specified in the Grantee's notice to the Company in accordance with the provisions of the New Share Option Scheme at any time thereafter and up to the close of such offer (or any revised offer) or the record date for entitlements under scheme of arrangement, as the case may be.

#### (17) RIGHTS ON WINDING UP

In the event of a resolution being proposed for the voluntary winding-up of the Company during the Option Period, the Grantee may, subject to the provisions of all applicable laws, by notice in writing to the Company at any time not less than two Business Days before the date on which such resolution is to be considered and/or passed, exercise his Option (to the extent not already exercised) either to its full extent or to the extent specified in such notice in accordance with the provisions of the New Share Option Scheme and the Company shall allot and issue to the Grantee the Shares in respect of which such Grantee has exercised his Option not less than one day before the date on which such resolution is to be considered and/or passed whereupon the Grantee shall accordingly be entitled, in respect of the Shares allotted and issued to him in the aforesaid manner, to participate in the distribution of the assets of the Company available in liquidation pari passu with the holders of the Shares in issue on the day prior to the date of such resolution. Subject thereto, all Options then outstanding shall lapse and determine on the commencement of the winding-up of the Company.

#### (18) GRANTEE BEING A COMPANY WHOLLY OWNED BY ELIGIBLE PARTICIPANTS

If the Grantee is a company wholly-owned by one or more Eligible Participants:

- (a) the provisions of paragraphs (12), (13), (14) and (15) above shall apply to the Grantee and to the Options granted to such Grantee, mutatis mutandis, as if such Options had been granted to the relevant Eligible Participant, and such Options shall accordingly lapse or fall to be exercisable after the event(s) referred to in paragraphs (12), (13), (14) and (15) above shall occur with respect to the relevant Eligible Participant; and
- (b) the Options granted to the Grantee shall lapse and determine on the date the Grantee ceases to be wholly owned by the relevant Eligible Participant provided that the Board may in their absolute discretion decide that such Options or any part thereof shall not so lapse or determine subject to such conditions or limitations as they may impose.

#### (19) CAPITAL REORGANIZATION

In the event of any alteration in the capital structure of the Company whilst any Option remains exercisable or the New Share Option Scheme remains in effect, and such event arises from a capitalization issue, right issue, consolidation or sub-division of the Shares, or reduction of the Share capital of the Company, then, in any such case the Company shall instruct the Auditors or an independent financial adviser to certify in writing the adjustment, if any, that ought in their opinion fairly and reasonably to be made either generally or as regards any particular Grantee, to (i) the number or nominal amount of Shares to which this New Share Option Scheme or any Option(s) relates (insofar as it is/they are unexercised); (ii) the Exercise Price of any Option; and (iii) (unless the relevant Grantee elects to waive such adjustment) the number of Shares comprised in an Option or which remain comprised in an Option, and an adjustment as so certified by the Auditors or such independent financial adviser shall be made, provided that: (i) any such adjustment shall give the Grantee the same proportion of the Shares in issue for which such Grantee would have been entitled to subscribe had he exercised all the Options held by him immediately prior to such adjustment; (ii) no such adjustment shall be made the effect of which would be to enable a Share to be issued at less than its nominal value; (iii) the issue of Shares or other securities of the Group as consideration in a transaction shall not be regarded as a circumstance requiring any such adjustment; and (iv) any such adjustment shall be made in compliance with such rules, codes and guidance notes of the Stock Exchange from time to time.

In respect of any adjustment referred to this paragraph, other than any adjustment made on a capitalisation issue, the Auditors or such independent financial adviser must confirm to the Board in writing that the adjustments satisfy the requirements of the relevant provisions of the Listing Rules.

#### (20) CANCELLATION OF OPTIONS

Any cancellation of Options granted but not exercised may not be cancelled except with the prior written consent of the relevant Grantee and the approval of the Board.

Where the Company cancels any Option granted to a Grantee but not exercised and issues new Option(s) to the same Grantee, the issue of such new Option(s) may only be made with available unissued Options (excluding, for this purpose, the Options so cancelled) within the General Mandate Limit or the limits approved by the Shareholders pursuant paragraphs (3) (b) and (c) above.

#### (21) TERMINATION OF THE NEW SHARE OPTION SCHEME

The Company by ordinary resolution at general meeting may at any time terminate the operation the New Share Option Scheme and in such event no further Options will be offered or granted but in all other respects the provisions of the New Share Option Scheme shall remain in full force to the extent necessary to give effect to the exercise of any Options (to the extent not already exercised) granted prior thereto or otherwise as may be required in accordance with the provisions of the New Share Option Scheme and Options (to the extent not already exercised) granted prior to such termination shall continue to be valid and exercisable in accordance with the New Share Option Scheme.

#### (22) RIGHTS ARE PERSONAL TO THE GRANTEE

An Option shall be personal to the Grantee and shall not be transferable or assignable and no Grantee shall in any way sell, transfer, charge, mortgage, encumber or otherwise dispose of or create any interest whatsoever in favour of any third party over or in relation to any Option or enter into any agreement so to do. Any breach of the foregoing by a Grantee shall entitle the Company to cancel any Option granted to such Grantee to the extent not already exercised.

#### (23) LAPSE OF OPTION

An Option shall lapse automatically (to the extent not already exercised) on the earliest of (a) the expiry of the Option Period; or (b) the expiry of the periods or dates referred to in paragraphs (12), (13), (14), (15), (16), (17) and (18).

#### (24) CLAWBACK MECHANISM

Unless the Board otherwise determined and stated in the offer of the grant of Options to a Grantee, there is no clawback mechanism under the New Share Option Scheme to recover or withhold the remuneration (which may include any Options granted) to any Eligible Participants in the event of serious misconduct, a material misstatement in the Company's financial statements or other circumstances.

#### APPENDIX III — PRINCIPAL TERMS OF THE NEW SHARE OPTION SCHEME

#### (25) OTHERS

- (a) The New Share Option Scheme is conditional upon the Listing Committee of the Stock Exchange granting the listing of and permission to deal in such number of Shares representing the General Mandate Limit to be allotted and issued by the Company pursuant to the exercise of Options in accordance with the terms and conditions of the New Share Option Scheme; and the passing of the necessary resolution to approve and adopt the New Share Option Scheme at general meeting of the Company.
- (b) Subject to paragraphs (25) (c) and (d), the New Share Option Scheme may be altered in any respect by a resolution of the Board except that:
  - (i) the provisions of the New Share Option Scheme as to the definitions of "Eligible Participants", "Grantee", "Option Period" and "Termination Date";
  - (ii) the provisions of the New Share Option Scheme relating to the matters governed by Rule 17.03 of the Listing Rules;

shall not be altered to the advantage of Grantees or prospective Grantees except with the prior sanction of a resolution of the Shareholders at general meeting (with all Grantees, prospective Grantees and their respective Associates abstaining from voting), provided that no such alteration shall operate to affect adversely the terms of issue of any Option granted or agreed to be granted prior to such alteration except with the consent or sanction of such majority of the Grantees as would be required of the Shareholders under the bye-laws of the Company for the time being for a variation of the rights attached to the Shares.

- (c) Any alterations to the terms and conditions of the New Share Option Scheme which are of a material nature or any change to the terms of Options granted shall be approved by the Shareholders at a general meeting, except where the alterations take effect automatically under the existing terms of the New Share Option Scheme.
- (d) Any change to the authority of the Board or the administrators of the New Share Option Scheme in relation to any alteration to the terms of the New Share Option Scheme must be approved by the Shareholders at a general meeting.
- (e) The terms of the New Share Option Scheme and/or the Options amended pursuant to this paragraph (25) must still comply with the applicable requirements of the Listing Rules.
